Meeting Summary

- 1. Call to Order/Verify Quorum: Chair Crosby called the meeting to order at 6:33 p.m. Michelle Godwin-Ware verified a quorum.
- 2. Approval of the Previous Meeting Summary: The May 10, 2021, summary was approved by the CPAC.
- 3. Elected Officials' Reports:
- 4. Nikki Evans, Executive Assistant to Council Member at Large Group 2, Ron Salem, provided an update on the Mental Health Offender Pilot Program (MHOP) and advised that the pilot program has been a success so far. Council Member Salem is working to make MHOP a permanent program.

- Warren Jones, Duval County School Board, reported that most of the schools on the west side are looking at a 90% graduation rate or higher. Mr. Jones also reported that they will be building a new school, Kindergarten through 8th grade on Chase Road. A design preview will be held in order to get the community's input. Mr. Jones announced that Rutledge H. Pearson Elementary is in design phase and will be the first elementary on the Southwest side to be replaced using the ½ cent referendum. Mr. Jones also announced that the Board voted unanimously to make wearing masks optional unless there is another serge in COVID-19 cases. The Board is still deciding on whether masks will be required on school buses. The student desk shields will only be used during group work at the elementary school level, and there will be no temperature checks, and no more Duval Virtual Homeroom. Parents who are not comfortable with their student returning to in person instruction may enroll their child in Duval Virtual at Florida if they wish to continue the virtual platform. - 5. Presentation: None
- 6. Jacksonville Sheriff's Office (JSO) Sgt. Abigail Ellis, reported that homicides are down 50 percent, home invasion robberies are up, car jackings have doubled, robberies to businesses are up, aggravated batteries are up, residential burglaries are down 22 percent, and auto burglaries are down 25 percent. Sergeant Ellis also reported that there has been a 76 percent increase in hit and runs. Sergeant Ellis advised that if anyone ever becomes a victim of a hit and run, they should try and get as much

information as possible; such as license plate number, vehicle description, and driver description in order help the investigation.

7. Chair's Report: Chair Crosby reminded CPAC members that there are still funds available for the mortgage relief program, which is available to those who have been affected by COVID-19. You may qualify for up to six months of mortgage payment or a \$7,500. payment will be made directly to the mortgage company. Chair Crosby also reminded CPAC members that the Neighborhood Services Office is offering Robert's Rules of Order Training on Thursday, June 24, 2021. The training is hybrid and registration is required. You may reach out to Ms. Godwin if you have further questions and would like to register.

8. Staff Reports:

- Animal Care and Protective Services (ACPS) Jennifer Walter, Chief ACPS, reported that to date the shelter has taken in 4000 animals, and is currently taking care of 800 animals total between in shelter and foster care. Ms. Walter reminded CPAC members that it is kitten season. So far, 800 kittens have been brought into the shelter. The shelter is looking for fosters and adoptive parents. Ms. Walter announced that ACPS has 15 Animal Control Officers servicing all of Duval County 365 days a year. Jennifer Walter may be contacted at ienniferw@coi.net
- Jacksonville Public Library (JPL) Lynne Baldwin, Executive Assistant Library Services I, reported that the library will be hosting a series of community meetings during the last two weeks in June as part of the Urban Branch Facilities Master Plan. The library is looking at five urban locations and their buildings, assessing to see if they are meeting the needs of their community. Murray Hill Library will host its community meeting on June 28, 2021, from 4:30 p.m. 7:30 p.m., and will provide a tour of the branch at 5 p.m. and 6 p.m. Ms. Baldwin announced that all 20 library branch locations are returning to pre COVID hours starting Monday, June 21, 2021. A list of hours can be found on the Jacksonville Public Library website www.jaxpubliclibrary.org. Ms. Baldwin also announced that the Summer Learning program began on June 1st. The Webb Westconnett branch will have in person story time every Tuesday at 10:30 a.m., through the end of July. - Municipal Code Compliance Division (MCCD) Ernest Murphy, Senior Code Compliance Officer, reported 1,074 inspections were completed, and 13,000 inspections have been completed year to date. A total of 333 snipe signs have bee removed over the past 30 days. The next systematic inspection will take place in the Oak Hill area. Currently there is no inspection date scheduled. Mr. Murphy reminded CPAC members that the Jacksonville Assistance and Relief Program (JAR) is still available for those who need abatement services due to disability or economic disadvantage. • **Public Works (PW)** – Jeremy Wright, Compliance Manager, reported that the widening of Chaffee Road is in its final planning phase. Construction of new sidewalks in accordance with pedestrian safety improvements plan will take place for Lenox Avenue beginning this summer. The Tillie Fowler Regional Park kayak launch, paved parking lot and paved trail project is 5 percent complete. Mr. Wright also reported that ADA compliant curb ramp improvements are taking place throughout Zone 4. A total of 432 ramps have been completed so far.

- **Transportation** Tom Martin provided the following report regarding the North Florida Transportation Planning meeting on June 2, 2021.

Organization (TPO) Citizens Advisory Committee (CAC) meeting:

- North Florida TPO CAC approved the CAC Membership request for two Duval County at-large members.
- North Florida TPO CAC approved the FDOT request to amend FY 220/21 through FY 2024/25
 Transportation Improvement Program (TIP). The projects include two resurfacing projects in Clay
 County, six resurfacing projects in Duval County, and two resurfacing projects in Nassau County. This
 amendment is for engineering work and is related to the difference in the start date and federal
 fiscal year.
- North Florida TPO CAC approved the proposed FY 2021/22 through FY 2025/26 Transportation Improvement Program (TIP). A complete draft is available on the North Florida TPO Website.
- North Florida TPO CAC received a presentation on the Jacksonville Aviation Authority by Mark Vanloh, CEO. Jacksonville Aviation Authority operates and maintains four airports: Jacksonville International Airport, Cecil Airport, Jacksonville Executive at Craig Airport and Herlong Recreational Airport. Cecil Airport is an industrial airport and a spaceport for horizontal launch spacecrafts. The JAA generates their income from the fees charged to users and tenant such as airlines, concessionaires, vehicle parking, leased land and buildings. Most of this income is used to offset operation and maintenance cost. Parking is their biggest source of income.
