## **Meeting Summary**

- 1. Call to Order/Verify Quorum: Chair Crosby called the meeting to order at 6:35 p.m. Michelle Godwin-Ware verified a quorum.
- 2. Approval of the Previous Meeting Summary: The August 9, 2021, summary was approved by the CPAC.
- 3. Elected Officials' Reports:
- 4. Nikki Evans, Executive Assistant to Council Member at Large Group 2, Ron Salem, reported that Council Member Salem is the chair of the Finance Committee and several items from August's budget hearings will be voted on during Tuesday, September 14, 2021, council meeting at 5 p.m., located in City Hall Council Chambers. Ms. Evans reported that there was extra money in the budget this year because of Cares Act funding. Every Council Member has funding at their discretion to allocate to a 501(C)(3) of their choice. Council Members have until Friday, September 17, 2021, to choose their nonprofit organization. Once the selections have been finalized, a masters list of the organizations that were funded will be created. Councilman Salem felt the Mental Health Resource Center was a good place to place that money, as well as Walk Off Charities, which provides all children in Jacksonville a chance to learn and play baseball for free. Ms. Evans also reported that the Mental Health Offenders pilot program is no longer a pilot program. The program has been extremely successful. - Taj Johnson, Legislative Aide to State Representative Angie Nixon, reported that Representative Nixon has formulated two Advisory Councils in District 14. The first council is made up of adults, the other is made up of middle school and high school students. Mr. Johnson also reported that Representative Nixon is working on the next Jax Melanin Market event scheduled for Saturday, September 18, 2021, located at 822 A. Philip Randolph Blvd. from 2 p.m. to 7 p.m. Representative Nixon has also partnered with Jacksonville Transportation Authority's (JTA) Human Resource office, who will be there to provide employment information and will be accepting applications.

- Warren Jones, Duval County School Board, reported that the school board voted to relocate the Duval County Public Schools headquarters to free up very valuable property. Board members will issue a "Intent to Negotiate" by the end of September to various companies who may be interested in purchasing the property. Mr. Jones reported that DCPS has implemented a mask mandate effective September 7, 2021, for all students. Schools are experiencing an increase in COVID-19 cases in a short period of time. Schools have only been in session for less than a month and have already experienced 2300 COVID-19 cases. Based on recommendations from the Centers for Disease Control and Prevention (CDC), the American Academy of Pediatrics (AAP), and the fast increase in cases; additional protocols needed to be put in place. Once a moderate threshold is reached, Superintendent Greene can remove the mask mandate. Mr. Jones also reported that the Health Department is experiencing a staffing problem, which is causing a delay in the contact tracing notifications and reports. DCPS is working with the Health Department and will use some of the Cares Act Fund to hire a private entity to provide contact tracing if necessary. Mr.

Jones reported that several educators were honored for their commitment to teaching economic and financial education. Three of the honorees were winners of a Regional Economic Educator and Leadership (REEL) Award, and one was recognized as the Economic Educator of the Year. - Matt Carlucci, Council Member at Large Group 4, spoke briefly about the gas tax and suggested CPAC members request Public Works provided a report on the types of projects that may come from the gas tax. Council Member Carlucci acknowledged that there is a major trash collection problem and advised that the City and private haulers are experiencing a labor shortage but are working to find a solution. Some areas of town have experienced tremendous growth compared to other parts of town. This will cause some council district lines to be redrawn. Council Member Carlucci advised that the Planning Department assists with the redistricting, and that Council Member Aaron Bowman is chair of the Redistricting Special Committee. - Jacksonville Public Library (JPL) Lynne Baldwin, Executive Assistant Library Services I, reported September is National Library Card Sign-up Month. Everyone is encouraged to renew their library card or get a new library card. The goal is for 75 percent of households in Duval County to be active library card users by 2029. Ms. Baldwin reminded CPAC member that the library is no longer charging overdue fines.

- Public Works (PW) Jeremy Wright, Facility Manager, reported that approximately 10.8 mile of the Jacksonville Baldwin Rail to Trail will be repaved. The notice to proceed will be issued on October 7, 2021. The Lenux Avenue sidewalk construction project between Old Middleburg Road to Memorial Park Boulevard is approximately 10 percent complete. The new kayak launch at Tillie Fowler Regional Park is 65 % complete. The contractor has built the pond, cleared the site and is in the final process of sub grading the kayak launch area. Mr. Wright also reported that 67 percent of the city-wide Americans with Disabilities Act (ADA) curb and ramp improvements are completed.
