- 1. Call to Order/Verify Quorum: Chair Green called the meeting to order at 5:34 p.m. Michelle Godwin-Ware verified a quorum.
- 2. Approval of the Previous Meeting Summary: CPAC approved May's summary.
- 3. Elected Officials: Executive Assistant to Council Member at Large Group 2, Ron Salem, provided an update on the Mental Health Offender Pilot Program (MHOP). The MHOP collaborates with the City of Jacksonville, Lutheran Services of Florida, the Public Offender's Office, JSO, Sulzbacher Center, and Gateway Community Services for programing. The purpose of the program has been to divert qualifying cases into a treatment program instead of the traditional court system. The pilot program has been a success, and Council Member Salem is working to make MHOP a permanent program. Council Member Salem will bring the bill before the Social Justice and Community Investment Committee, in the hopes that it will pass in order for the program to continue for another year.

- Animal Care and Protective Services (ACPS) Jennifer Walter, Chief ACPS, reported that to date the shelter has taken in 4000 animals, and is currently taking care of 800 animals total between in shelter and foster care. Ms. Walter reminded CPAC members that it is kitten season and so far, 800 kittens have been brought into the shelter. The shelter is looking for fosters and adoptive parents. Ms. Walter reported that there are a few different ways to report an animal emergency after hours. One way is to call JSO's non-emergency number (904)630-0500. If it is an emergency JSO will reach out to the Animal Control Officer on duty. Members may also download or use the Myjax.custhelp.com app. The request submitted through the Myjax application transfers to the ACPS system, where the animal control officer on duty also monitors emergencies. Ms. Walters advised CPAC members that in order for an Animal Control Officer to

- cite a citizen without the officer witnessing the violation, an affidavit must be filled out and sent in to ACPS including photos or video. The affidavit can be found on ACPS's website, or you can email the Shelter at JaxPets@coj.net and request a form.

- Jacksonville Sheriff's Office (JSO) Lt. Joel Van Delinder, reported that Zone 6 is still having a problem with car theft and burglary because people are leaving their car doors unlocked. Lt. Van Delinder asked CPAC members to share what they are learning during CPAC with their community. Lt. Van Delinder announced that JSO has plans to go out into the community to continue encouraging people to report suspicious activity, to lock their car doors, as well as the doors to their homes.

 for a safe and reliable hurricane season. Mr. Knowles encouraged the CPAC Members to

 reported that 35 neighborhoods in Jacksonville have failing septic tanks. The Bilmore C, Beverly
 Hills East, Beverly Hills West, and Christobel neighborhoods are in the most need of phase out
 because of environmental safety issues.
