- 2019-0717 Planned Unit Development: 0 Newcomb Road This application seeks to rezone approximately 450.33 +/- acres from PUD to PUD. The rezoning is being sought in order to allow the development of 1,100 to 1,400 residential units ranging between 40 foot wide lots to 70 foot wide lots. The final unit lot count shall not have more than 40 percent of the lots designated 40 foot lots.
- 2019-0719 Conventional Rezoning: 0 Dunn Avenue This application seeks to rezone approximately 15.10 +/- acres from Planned Unit Development to CN along Dunn Avenue and RMD-A to the north of the property bordering the existing residential. The applicant is seeking a mixed use project of Neighborhood Commercial uses and residential.
- 2019-0749 Planned Unit Development: 15324 Max Leggett Pkwy. This application seeks to rezone approximately 22.51+/- acres from PUD to PUD, to allow for Multi-Family residential uses in addition to commercial an office uses. Multi-Family will be limited to 300 dwelling units and approximately 100,000 square feet of enclosed nonresidential uses.
- 2019-0756 Conventional Rezoning: 0 Duval Road This application seeks to rezone approximately 14.82 +/- acres from RR-Acre to RLD-40 for single family dwelling with lots ranging between 40 foot wide lots to 45 foot wide lots.
- **Z-2519 Conventional Rezoning: 15480 Max Leggett Pkwy.** This application seeks to rezone approximately 1.66+/- acres from PBF-2 to CCG-1 to allow for the development of the property with commercial uses allowed in CCG-1. Erin Abney may be contacted at (904) 255-7849 or eabney@coj.net
