If a citizen received the first Mortgage and Rent Relief program assistance of \$1,000, he/she may apply and the \$1,000 will be deducted from the possible \$5,000.

- AD-20-71 Administrative Deviation: 16022 Red Bass Dr.: This application seeks a deviation to reduce the required minimum lot area for a property located in zoning district RR-Acre from 43,560 square feet (1 Acre) to 35,284 square feet for the development of 1 single-family dwelling.
- V-20-20 Variance: 6669 Rivercrest Dr.: This application seeks to allow an increase in the accessory structure square footage from 1,700 sq. ft. allowed to 2,400 sq. ft.
- WRF-20-24 Waver of Road Frontage: 1701 Pecan Park Rd.: This application seeks to reduce the required Road Frontage requirement from 35 feet to 0 feet to build a singlefamily home.
- 2020-0603 Conventional Rezoning: 5400 Cedar Point Rd.: This application seeks to rezone approximately 2.70+/- acres from Residential Rural-Acre (RR-Acre) to Agriculture (AGR) to allow for agricultural uses on the subject property.
- 2020-0658 Planned Unit Development (PUD) Jax Commerce Center: This application seeks to rezone approximately 1837+/- acres from PUD/PBF-3/PBF-2/IL to Planned Unit Development (PUD). The purposed PUD represents a targeted strategy to ensure appropriate types of land uses are developed in and around JIA.
- 2020-0661 Planned Unit Development (PUD): Cedar Point Road: This application seeks to rezone approximately 10.36 +/- acres from RR-Acre to Planned Unit Development (PUD) to permit the development of a residential community consisting of 17 single-family lots minimum 80-foot-wide lots and 12,000 square feet in size.
- 2020-0689 Administrative Deviation: 16022 Red Bass Dr.: This application seeks a

deviation to reduce the required minimum lot area for a property located in zoning district RR-Acre from 43,560 square feet (1Acre) to 35,284 square feet for the development of one single family dwelling.
