- V-20-12 Variance: 2836 Scarwin Lane This application seeks to allow an increase in the accessory structure square footage from 648 sq. ft. allowed to 720 sq. ft. During the full CPAC meeting, CPAC members unanimously approved the Governmental Affairs Subcommittee's motion to take no action.
- V-20-13 Variance: 13640 Dunn Creek Road This application seeks to allow an increase in the accessory structure square footage from 873 sq. ft. allowed to 4032 sq. ft. During the full CPAC meeting, CPAC members unanimously approved the Governmental Affairs Subcommittee's motion to recommend the denial of the application.
- 2020-0572 Conventional Rezoning Betz Road This application seeks to rezone approximately 1.25 acres from Agriculture (AGR) to Residential Rural Acre (RR-Acre) to build a single-family home on the property. During the full CPAC meeting, CPAC members unanimously approved the Governmental Affairs Subcommittee's motion to take no action.

- 2020-0601 (Z-3068) PUD: 16105 Main Street This application seeks to rezone approximately 10.79 acres from RR-Acre/CCG-2 to Planned Unit Development to develop a single-family residential subdivision. The development will consist of up to 60 single family dwellings ranging between 40 and 50-foot-wide lots. During the full CPAC meeting, CPAC members unanimously approved the Governmental Affairs Subcommittee's motion to recommend the denial of the application.
