- 5. Staff Reports:
- Jacksonville Sheriff's Office (JSO) Zone 6 Assistant Chief Gregory Burton reported that car crash fatalities are down. Zone 6 has put in place a Driving Under the Influence (DUI) deployment. This has resulted in several arrests. Chief Burton announced that JSO Zone 6 newsletter is not digitalized yet, but he is working on it and is the only zone that has one.

- Jacksonville Fire and Rescue Department (JFRD) Battalion Chief Trace Barrow reported that Zone 6 received an ISO Fire Suppression rating of one from Insurance Services Office (ISO) this year. The Fire Suppression Rating Service (FSRS) evaluates four primary categories of fire suppression: fire department, emergency communications, water supply and community risk reduction. The FSRS includes standards set by the National Fire Protection Association. A rating of one is the highest ratings, and will help decrease home insurance rates.

Ms. Riddick also reported that JTA offers ReadiRide curb to curb service for many in the area. For 50 cents, JTA will come to your door and pick you up and drive you to the nearest bus stop. Ms. Riddick announced that on September 30th fare modifications took place. Fare for seniors 65 and older have remained the same. Ms. Riddick also announced that JTA is holding a series of public meetings and hearings to seek public input on the proposed route changes to 28 routes in Downtown Jacksonville. These changes are associated with the opening of the Jacksonville Regional Transportation Center at LaVilla, as well as the changes to the boundaries of the Southwest ReadiRide zone.  - The Governmental Affairs Committee reported on the following:

New Business

- E-19-56 Exception: 12501 Sawpit Rd.. This application seeks to allow the excavation of a borrow pit on the subject property. The borrow pit is located 450 feet from the right of way and 300 feet from adjacent properties. A motion to defer until a community meeting can be held was made by Tommy Ruffin and seconded by Mike Getchell. CPAC members unanimously approved.
- SW-19-07 Sign Waiver: 1338 Dunn Ave. This application seeks to reduce the required setback from a property line for a sign from 10 feet to 1 foot. The sign was first constructed in 1983, and due to the widening of Dunn Avenue; the sign does not meet the required 10 foot setback. The applicant wants to change out the face of the sign which requires that the sign be brought into compliance

- with sign waiver application. A motion was made by Mike Getchell and seconded by Tommy Ruffin that if the owner makes changes to the existing sign he should come into compliance with the existing code. CPAC members unanimously approved the motion.
- 2019-0635 Planned Unit Development: 14670 Duval Rd. This application seeks to rezone approximately 28.86 acres of land from CCG-1 and IBP to Planned Unit Development (PUD). The rezoning is being sought in order to permit development of mixed-use development which will include a hotel establishment with medical and care-based facilities and/or multi-family residential uses. A motion to support with conditions that the blood donor stations, plasma centers and similar uses would be deleted and that the main use for parcel B would be for multi-family dwelling, limited to 85 units, or as a senior living facility, limited to 100,000 square feet. The motion was seconded by Tommy Ruffin. CPAC members unanimously approved.
