Meeting Summary

- 1. Call to Order/Verify Quorum: Chair Green called the meeting to order at 5:31 p.m. Michelle Godwin-Ware verified a quorum.
- 2. Approval of the Previous Meeting Summary: CPAC approved August's summary.
- 3. Elected Officials:
 - Kelly Coker, Duval County School Board, reported that this year's enrollment is up by 2500 students. Ms. Coker reported that they are working on correcting any transportation pick up and drop off issues but are short staffed. Ms. Coker also reported that the COVID-19 dashboard will be used again this year to report the number of students and staff with confirmed positive cases of COVID-19. Unfortunately, 10 DCPS staff members, and several students have passed away because of COVID-19 this year. The dashboard can be found on the DCPS website https://c19sitdash.azurewebsites.net/. Ms. Coker reported that she is on the Special Committee on Redistricting, and advised CPAC members that the meetings are open to the public.  - Michelle Worley, Executive Secretary to State Representative Angie Nixon, reported that Representative Nixon has formed two Citizen Advisory Boards to help her form her legislative plan for the upcoming session beginning January 2022. Ms. Worley advised CPAC members that the office is currently closed because of the surge of COVID-19 cases, but Representative Nixon may be reached by calling the office.

 - Matt Carlucci, Council Member at Large Group 4, spoke briefly about the gas tax and suggested CPAC members request Public Works provided a report on the types of projects that may come from the gas tax. Council Member Carlucci acknowledged that there is a major trash collection problem and advised that the City and private haulers are experiencing a labor shortage but are working to find a solution. Council Member Carlucci advised he would be

happy to help in any way he can. Council Member Carlucci advised that redistricting is determined by the size of the population. Some areas of town have experienced tremendous growth compared to other parts of town. This will cause some council district lines to be redrawn. Council Member Carlucci advised that the Planning Department assists with the redistricting, and that Council Member Aaron Bowman is chair of the Redistricting Special Committee. - Jacksonville Sheriff's Office (JSO) Lt. Joel Van Delinder, reported that JSO is aware of the street racing that is taking place at the Port of Jacksonville. The traffic unit is working on the problem. Lt. Joel Van Delinder may be reached at (904) 696-4335
- Jacksonville Public Library (JPL) Jackie Spiritas, Executive Assistant I, reported that September 15 through October 15 is Hispanic Heritage month. The libraries will be recognizing the history, culture, and contributions of American citizens of Spanish and Latin American origin. Ms. Spiritas also reported that September is also National Library Card Sign-up Month. Storytime will start backup soon and will operate as Pop-up Storytime. Pop-up Storytime will be scheduled on different days outside on the lawns of various regional libraries around town. Registration is required, and information can be found on the Jacksonville Public Library website www.jaxpubliclibrary.org. Ms. Spiritas reported that the Main library is closed while being used as a Regeneron Treatment Site. The Regeneron treatments take place in the Conference Center off the Main Street entrance. If there are any questions regarding Regeneron treatments, CPAC members may call the support line (850) 344-9637. Ms. Spiritas shared that, three local architects will interview on Thursday, September 9 to design the new Oceanway library. The design phase is scheduled to take 10 to 12 months, after which the construction company will be hired to build the facility. The building is estimated to be completed in 2023 or 2024. Public input regarding the design will be allowed.

- Municipal Code Compliance Department (MCCD) Charles Benson, reported that 449 snipe signs were removed. A total of 1,061 inspections were completed in the month of August. Mr. Benson advised that the MCCD is working to keep the Marathon Gas Station, Walgreens, and CVS along Dunn Avenue accountable for the cleanliness of their properties. A plant growth regulator will be used to make the grass grow at a slower rate. Mr. McDaniel announced that the Capital Improvement budget (plan) passed and will go into effect January 1, 2022.

The Governmental Affairs Subcommittee reviewed 7 Land Use and Zoning applications, and two recommendations were made:

New Business

- V-21-14 Variance: 13321 Beall Avenue: This application seeks to increase the square footage of an accessory structure. Increasing the accessory structures height from 15 ft. To 19 ft. and reduce the required yards from 5 ft to 1.4 ft on the east plane and 2 ft on the north plane. The CPAC opposed the project due to the project being completed before seeking the proper variance.
- Z-3608 Planned Unit Development (PUD) 0 Main Street: This application seeks to rezone approximately 92.24 acres from Industrial Light (IL) to Planned Unit Development (PUD) to permit the development of 217 single family dwellings and 146 duplexes. The CPAC oppose the project due to the 40 ft lots.
