- Noah Ray, JFRD Emergency Preparedness Supervisor, presented on the City of Jacksonville Emergency Preparedness Division's Mitigation Strategy Update. Mr. Ray explained that the purpose of the mitigation strategy is to reduce the loss of life and property by lessening the impact of disasters. Mr. Ray advised that in order to change the outcome of some direct and indirect actions, Duval County is creating a risk assessment committee to work on revision of the current plan.   has been closed. Chief Burton announced that the three year survey came out and Zone 6 came in
  second for approval of services provided.

- AD-19-47 Administrative Deviation: 5118 Heckscher Dr. This application seeks to reduce the
  required uncomplimentary buffer from 10 feet to 0 feet along East and West property
  boundaries including removing the required trees and visual screening from required buffer. A
  motion to oppose was made by Dot Mathias and seconded by Teresa Moore. CPAC members
  unanimously approved.
- 2019-0517 Conventional Rezoning: 0 Pine Estates Rd. W. This application seeks to rezone approximately 1.5 acres from RR-Acre to RLD-60 in order subdivide the property and develop single family home 60ft. in width. A motion to oppose was made by Teresa Moore and seconded by Mike Getchell. CPAC members unanimously approved.
- 2019-0493 Planned Unit Development (PUD): 0 New Berlin Rd. This application seeks to rezone approximately 16.99 Acres from PUD 2002-0665 to PUD to allow development of no more than 140 townhomes on the North Parcel and neighborhood commercial uses on the Southwest Parcel. A motion to oppose the PUD in its present form was made by Teresa Moore and seconded by Mike Getchell. CPAC members unanimously approved.
- 2019-0497 Planned Unit Development (PUD) 10836 Lem Turner Rd. This application seeks to rezone approximately 3.34 acres from CCG-1 to PUD for an Outdoor Storage Facility for Recreational Vehicles, Trailers and Boats for long term storage. A motion to take no action was made by Teresa Moore and seconded by Reverend Joseph Tate. CPAC members unanimously approved.
