- 1. Call to Order/Verify Quorum: Chair Mike Getchell called the meeting to order at 5:45 p.m. Michelle Godwin verified a quorum.
- 2. Approval of the Previous Meeting Summary: CPAC member Joseph Tate motioned to approve January's summary. CPAC member Teresa Moore seconded. The motion unanimously passed.

### 3. Presentation:

Dr. Diana Greene, Superintendent of Duval County Public Schools (DCPS) reported that DCPS is the second largest employer in Duval County and services 188 schools, including charter schools. These schools serve 130,223 students, and have 14,000 employees. In 2017-2018, \$122 million in scholarships were awarded to DCPS students. Dr. Greene also announced that every high school has career academies. There are 110 career tech (CTE) high school programs in the DCPS. Dr. Greene announced that this school year, Duval County School board members will be prioritizing several areas: becoming an "A" district, safety and security of schools and financial solvency-increasing the districts fund balance. Dr. Greene announced that DCPS has received a grant that has been used to supply 115 cameras in every high school, two walk through metal detectors and 12 hand held metal detectors. The cameras should be installed by February. District middle schools will have 55 cameras installed. Dr. Greene also announced that by the end of the school year, every school will have a visitor's management system that will scan a visitor's information, checking for felonies and checking if the visitor is on the sexual offenders and predators list. Dr. Greene announced that for every school that has 2,000 students, there will be two school safety officers placed at that school. Dr. Greene also announced that the school board is creating a financial

dashboard, which will be available to citizens to view in real time, showing how money is being spent. The financial dashboard is being created in order to provide financial transparency. Dr. Greene advised that UNF will be partnering with DCPS in its early college program. Students will need a higher grade point average in order to participate in the program.

Lurise Bannister, Planning Services Manager Transportation, Planning and Development presented on Ordinance #2017-0807. The bill amends Ordinance Code Chapter 804 – Jacksonville Traffic Code – to create a new Part 15 – Truck Route Regulations. The new part provides numerous definitions, establishes "truck route criteria," provides for the designation of truck routes and the posting of signage, designates the initial list of truck routes, establishes enforcement and penalties, and tasks the Planning and Development Department with providing an educational program in conjunction with the Jacksonville Sheriff's Office to educate the public about street functional classifications and the location of truck routes. The City Traffic Engineer will install signage to identify designated truck routes. Enforcement of truck route regulations will be performed by the Sheriff's Office and violations will result in a civil citation for a Class C offense resulting in a \$100 fine.
