- 3. Elected Officials:
- Council Member Samuel Newby, At Large Group 5, reported that there is now a Commission on Safety and Crime Reduction, comprised of approximately half of the members from the Safety and Crime Reduction Task Force.

- 4. Presentation
- Wiley Page, Atkins, Eastern US Transportation Planning Manager, presented on North Florida Transportation, 2045 Regional Long Range Transportation Plan (LRTP). Mr. Page explained that the Transportation Planning Organization began updating the 2040 LRTP to 2045. The Needs Plan, which is a list of needed projects that are not hindered by project cost or available revenue, will be added to the 2045 LRTP. The new plan includes roadway projects, bicycle and pedestrian projects, public transportation projects, as well as projects that support the SMART Cities, safety, and operational initiatives of TPO.

- Detective Abigail McCaughey, explained how the new ShotSpotter system can alert and lead police to gunshots and even locate vehicles or suspects in surveillance video. Detective McCaughey explained that the new system allows for faster response time in active shooter cases. The system is used primarily in parts of town with extreme gun violence. ShotSpotter is not used in Planning District 6.

- 5. Staff Reports:
- Jacksonville Sheriff's Office (JSO) Zone 6 Assistant Chief Gregory Burton reported that Zone 6 is the second leading zone for car crash fatalities. Zone 6 Officers will be working traffic in order to slow people down and decrease fatalities. Chief Burton announced he was able to contact developers about the sign on the corner of Armsdale Road and Duval Road. He was able to get them to move the sign back three feet. Complaints about the sign are still being made, so Chief Burton has

reached out to COJ Risk Manager Twane Duckworth, who will have Traffic and Engineering make an assessment regarding visibility. Chief Burton announced that JSO Zone 6 now has a newsletter and is the only zone that has one.

- Jacksonville Electric Authority (JEA) Berdell Knowles, Government Affairs Specialist/Director of Regulatory Affairs, reviewed JEA's Restoration 1, 2, 3 processes. Mr. Knowles advised CPAC members to keep their thermostats set at 78 degrees in order to save cost during the summer. He also advised CPAC members to be aware of running water and leaks because these things can negatively affect your electric bill.

CPAC members unanimously approved.
