- a. Application for Disability Retirement
 - 1. WEATHINGTON, Jason L., Police Officer

Hearing Order of Presentation:

a. Call to order and determination of quorum

James Holderfield noted there is a quorum of six members out of a total seven on the Advisory Committee. Richard Reichard is not present today.

b. Offer applicant postponement if all members of Advisory Committee not present

James Holderfield offered to defer today's hearing, because there was not a full committee.

Tad Delegal said we prefer to go forward today.

c. Ask for any public comments (in case City, JSO or union have concerns they want to address)

There were no requests to make public comments.

- d. PFPF lawyer gives opening statement
 - i. Describing order of hearing

Bob Sugarman discussed the order of today's hearing. He described the duties of the Advisory Committee to hear the member's argument attempting to prove he is entitled to a disability pension under the code provisions. The applicant bears the burden of proof. The applicant or lawyer must prove that each item (ii) below is 'yes'. If one is 'no', then the member is not entitled to a disability pension under the code provisions.

- ii. Asking applicant or lawyer to focus on these questions and evidence in record that shows answer to each one is "yes":
 - 1. Did applicant suffer an injury or illness
 - 2. Did it cause the applicant a disability? If so, what can he not do now that he was able to do before illness or injury?
 - 3. Is the disability permanent and total? Explain concept of maximum medical improvement?
 - 4. Does this disability prevent the applicant from rendering useful and efficient service as a Police Officer or Firefighter?
- e. Applicant or lawyer presents case.

Tad Delegal, attorney for member Jason Weathington, presented the argument for granting Jason Weathington a disability pension. He argued that due to the severity of his symptoms, Jason Weathington is unable to perform effective work, and should be granted a disability pension.

Sonya Harrell, of the Office of General Counsel, presented an opposing point of view. Her argument is that the Jacksonville Sheriff's Office has offered reasonable accommodations to Jason Weathington, accommodating his disability. She argued that because he has an available job, consistent with the Collective Bargaining Agreement, the Advisory Committee should not grant payment of a disability pension.

Jason Weathington was sworn in by Jennifer Alligood, Court Reporter.

Tad Delegal questioned Jason Weathington regarding the circumstances leading to his disability, and the symptoms arising from the injury. He questioned Jason Weathington on how these symptoms affect his ability to work in the TeleServe unit of JSO (light duty). He discussed the physician's letters regarding Jason Weathington's disability and symptoms, and how they affect his ability to work.

Jason Weathington described his symptoms, and agreed that these symptoms prevent him from performing useful and efficient service as a Police Officer.

Sonya Harrell questioned Jason Weathington regarding his symptoms and how they affect his ability to work. She also asked about his annual leave, and if he applied for FMLA or any disability accommodations.

f. Advisory Committee questions of applicant or lawyer.

Thomas Lumpkin, Michael Pelletier, and Michael Shell asked questions of Jason Weathington concerning his disability.

James Holderfield recessed the meeting at approximately 10:35AM.

James Holderfield resumed the meeting at approximately 10:45AM.

Sgt. Jody Kirkland was sworn in, and testified as a witness.

Tad Delegal, Sonya Harrell, James Holderfield, Michael Shell, and Michael Pelletier questioned Sgt. Kirkland regarding Jason Weathington's performance as a police officer when he served under Sgt. Kirkland.

Stephanie Harris, JSO Occupational Health Manager was sworn in, and testified as a witness.

Sonya Harrell, Tad Delegal, James Holderfield, Michael Shell, Thomas Lumpkin, and Michael Pelletier questioned Stephanie Harris regarding timesheets, leave, FMLA, TeleServe, and reasonable accommodations.

Tad Delegal gave his closing argument, and said that Jason Weathington is entitled to a disability pension based on evidence from doctors, and Stephanie Harris's testimony.

Sonya Harrell gave her closing argument, and said that Jason Weathington is not entitled to a disability pension because he is able to perform useful and efficient service in TeleServe.

g. Chairman asks for motion either

i. Recommending granting of application

James Holderfield asked if there was a motion to recommend approval of Jason Weathington's application for disability pension.

No motions were made.

ii. Denying application with reasons for denial, or

James Holderfield asked if there was a motion to recommend denial of Jason Weathington's application for disability pension.

Michael Shell made a motion to recommend denial of Jason Weathington's application for disability pension based on item number 4. Seconded by Michael Pelletier. Discussion:

Michael Shell said he has great empathy for Jason Weathington's injury. He said he understands his pain, but JSO has a longstanding history and tradition of accommodation.

The vote passed unanimously.

iii. Tabling vote in case Advisory Committee wants more information

The vote was not tabled.

James Holderfield asked Chuck Hayes to make sure the disability pension reapplication process was provided to Jason Weathington.

Tad Delegal asked when the next Board of Trustees meeting will be held

Steve Lundy said the next Board meeting is scheduled for January 17th at 9AM.

Tad Delegal said he would like the transcript, and the opportunity to write to the Board of Trustees in February. January may be difficult in 9 days.

Timothy Johnson said he has no problem giving the member time to prepare for the Board of Trustees level. We will review the procedures to ensure due process, and to give lawyers the opportunity to address the Board of Trustees.
