Thomas Lumpkin moved to retain James Holderfield as Chair, seconded by Richard Reichard. The vote passed unanimously.

#### b. Vice Chair

Michael Shell moved to retain Richard Reichard as Vice Chair, seconded by Michael Pelletier. The vote passed unanimously.

James Holderfield updated the committee, noting that the Fund's Medical Director has advised that Mr. Livingood is 100% disabled and unable to perform his duties as a police officer, including administrative or support positions.

Michael Shell noted that to be consistent with the prior disability application (Jason Weathington), there needs to be further attempt with the employer regarding accommodation.

The Advisory Committee discussed the communications between Mr. Livingood and JSO regarding accommodation, as contained in the disability application file.

Chris Dempsey, Counsel for Mr. Livingood, said that there is no accommodation that could be afforded to Mr. Livingood, and submit that his application should be approved.

James Holderfield asked for a motion, in order to continue discussion.

### Michael Pelletier moved to accept Mr. Livingood's disability application. Discussion:

Michael Shell said that precedence and consistency is important, and we need to give JSO a chance to accommodate.

Richard Reichard said he agreed and there is not enough information.

Timothy Johnson retrieved the disability application file for the Advisory Committee to inspect.

The Advisory Committee members reviewed the file, and discussed JSO's history of accommodating employees with disabilities, and the Medical Director's review of the file.

### Michael Pelletier's motion was not seconded, and died.

Michael Shell moved that the Advisory Committee place Mr. Livingood's disability application on hold until JSO has an opportunity to respond, and the Advisory Committee would hopefully reconsider next month, seconded by Richard Reichard. The vote passed unanimously.

(Note: Cpt. Stover could not attend the meeting live due to a scheduling conflict and his vote of 'aye' was not counted. Lt. Paravisini could not attend the meeting due to sickness, and therefore his vote of 'aye' was counted.)

Bob Sugarman said that his office is working on a revised disability policy, which would not apply to Mr. Livingood's case. The recommendation would be that once a member files an application for disability retirement, the process is frozen and the application is judged at the time of application. If there is any new information, it must wait 6 months to be refiled. The temporary disability benefit would apply for 6 months, so there is no pause in benefits.

Thomas Lumpkin asked if the information today could be shared due to HIPAA.

Bob Sugarman said that the details of the disability application are confidential, except during the meeting. The file cannot be shared outside of the public meeting. The member signs a release.

Lawsikia Hodges said there is nothing new to report from OGC.
