IV. Executive Director's Report

Timothy Johnson said the July meeting hiatus was relaxing, and everyone was glad to take a month off. Next year, we will plan a full 12 meetings, but may take another hiatus if warranted.

Timothy Johnson said that each year, he sends an email to the Advisory Committee, FIAC, and Board of Trustees asking for input and feedback related to planning the next fiscal year's performance plan. Last year resulted in 12 broad goals we sought to accomplish. We also do a member survey to help create the tightest performance plan for the next year.

a. DROP Applications & Pension Benefit Estimates Update

Steve Lundy updated the Advisory Committee on the progress of the DROP applications. Earlier in the year, PFPF Staff surveyed eligible members to gauge interest in DROP enrollment. Through the third quarter, the actual DROP enrollment numbers were exactly as expected based on the survey results. Concerning the October 2021 DROP, PFPF Staff expected 175 enrollments. Due to the recent collective bargaining discussions, and proposed raises, DROP enrollments for October were lower than expected.

Chuck Hayes said that Lynn West has met with over 100 members interested in the October DROP, and 75 have enrolled.

Steve Lundy updated the Advisory Committee on the unprecedented amount of retirement estimates requested by members. Last month, we saw an increase of over 1,600% in retirement estimates. He said that some days he would send over two dozen estimates to members.

James Holderfield said he would like to see the latest DROP Enrollment Statistics page.

Steve Lundy said he would present the updated DROP Statistics next month.

James Holderfield said a lot of members have told him they appreciate the extra work and effort the PFPF Staff have performed during this time of increased retirement interest. He also asked about the new workshop.

Steve Lundy said the PFPF Staff is debuting a new workshop on August 30th at 10AM at the PFPF Office and ZOOM. The Mid-Career Workshop targets members in the middle of their career, and covers all retirement options, and expected payouts, among other topics.

V. Counsel Reports

Bob Sugarman and Lawsikia Hodges said they have nothing new to report.

James Holderfield thanked Bob Sugarman for all his behind-the-scenes work.

Bob Sugarman said he appreciates being able to appear via ZOOM, as he is in Philadelphia and his newest grandchild was just born hours ago.

James Holderfield congratulated Richard Reichard on his enrollment in the DROP, and that everyone signed his application today.

Bob Sugarman said that since Richard Reichard is on the Advisory Committee, it should be removed from the consent agenda and voted upon separately with Richard Reichard abstaining.

NOTE: Richard Reichard's application was on the June 2021 Advisory Committee agenda, not August 2021. Richard Reichard was absent in the June 2021 Advisory Committee meeting, and therefore did not vote on his own application.

Thomas Lumpkin moved to remove Richard Reichard's DROP application from the agenda, seconded by Michael Shell. The vote passed unanimously.

Richard Reichard said he would not vote on his application.

Christopher Stover moved to approve Richard Reichard's DROP application, seconded by Jean Paravisini. The vote passed unanimously, with Richard Reichard abstaining.

Bob Sugarman said that Richard Reichard would need to complete ethics form 8-B.
