II. Reemployed Pensioners Ordinance

Timothy Johnson said this new ordinance would allow recently retired members to become reemployed during the COVID-19 pandemic. The Board of Trustees may provide comment on this ordinance. He said he asked the Chair to call a Special Meeting to review. Steve Lundy sent the draft ordinance to Trustees, and Pete Strong has provided a 'no actuarial impact' letter.

Lawsikia Hodges said OGC has been working with the unions on this ordinance, and both unions have signed off on the ordinance as filed in its current state. If the Board has any comments today, the Board may direct Timothy Johnson to relay the comments to City Council. This is an 'in and out' emergency legislation. The goal of all parties is to get this passed as soon as possible. The FIAC is not required to comment on this legislation.

Bob Sugarman said Jacksonville is far ahead of the curve for all other cities in Florida. He said he recommends the Board of Trustees to endorse this legislation and urge City Council to pass it. There is no loss or gain to the Fund. There are no IRS issues either. Members will be able to return to work as police officers or firefighters.

Chris Brown asked if there was a motion to endorse the legislation.

Terry Wood made a motion to endorse the legislation, to urge City Council to pass it, and to relay the information that there will be no impact to the Fund. Seconded by Nawal McDaniel. Discussion:

Terry Wood asked if this would result in any administrative difficulties for the Fund Staff.

Timothy Johnson said it would not, except it may complicate the affidavit process where members must disclose if they have been reemployed with the City.

Lawsikia Hodges said the members would be fine. The question on the affidavit asks if they are reemployed, and their answer would be yes. This reemployment would be covered and approved.

Bob Sugarman said the pension office could ask JSO and JFRD for lists of their temporary employees. This would make administration of the affidavits as easy as possible.

Lawsikia Hodges asked if there was any public comment.

Steve Lundy said there were no requests for public comment.

The vote passed unanimously.

Chris Brown asked if we should send the information to the Bureau of Retirement Systems.

Bob Sugarman said yes, the fund staff would administratively send that information to be transparent, even though there is no impact, and members would not make contributions to the fund.

Bob Sugarman thanked Pete Strong for his quick turnaround of his actuarial impact letter. After receiving the draft ordinance, he turned around his letter in about 90 minutes. He said this was the fastest turnaround he has ever seen for an actuary. He congratulated the Board of Trustees for hiring Pete Strong as actuary, and to GRS for coming through when we really needed him.
