Summary

Renzer Bell gave public comment.

II. Manager Update

a. Katie Hammond, Lawrence Ostow, Jason Curran, JP Morgan

Katie Hammond, Lawrence Ostow, and Jason Curran from JP Morgan provided a comprehensive update on their firm's activities to the Board and FIAC members. JP Morgan currently oversees an approximate \$212 million Core Real Estate allocation within the Police and Fire Pension Fund.

Lawrence Ostow's presentation covered key aspects such as J.P. Morgan Real Estate Americas, highlighting their premier position as a manager of real estate in open-end funds. The depth of their Real Estate Americas platform, boasting \$75 billion in assets under management, was emphasized. Additionally, Ostow discussed the Strategic Property Fund Investment Team and Partners.

Shifting focus, Jason Curran addressed Strategic Property Fund positioning, emphasizing high conviction, execution, and outperformance drivers. He provided insight into fund sector statistics, including sector exposure, NOI growth, and sector occupancy across various segments like Industrial, Residential, Office, Retail, and Extended Sectors. Curran also delved into portfolio geographic allocation, the repricing strategy from 3Q22 to 3Q23, and highlighted the short-term repricing impacts that filter through to long-term results. Noteworthy aspects of the residential fund, including subsectors like Extended Residential, Sunbelt, Mixed Income Urban, Urban Core, and Coastal Suburban, were also covered along with insights into the balance sheet.
