CONTRACT BETWEEN THE CITY OF JACKSONVILLE AND AQUINO CONSTRUCTION, INC. FOR CAHOON ROAD ENDWALL CONSTRUCTION

THIS CONTRACT is executed as of this 30 day of 50, 2014, by and between the CITY OF JACKSONVILLE, FLORIDA, a municipal corporation in Duval County, Florida, (hereinafter sometimes the "Owner" or the "City"), and AQUINO CONSTRUCTION, INC., a Florida profit corporation with office at 8638 Stanmoor Court, Jacksonville, Florida 32244 (hereinafter the "Contractor").

WITNESSETH, that for the consideration and under the provisions hereinafter stated and referred to moving from each to the other of said parties respectively, it is mutually understood and agreed as follows:

- 1. That Contractor is the lowest and best responsible bidder for furnishing all labor, materials, and equipment and performing all operations necessary for the Cahoon Road Endwall Construction Project on Cahoon Road near its intersection with Homestead Oaks Drive, including but not limited to demolition, hauling and disposal, regrading, sodding, endwall construction, general earthwork in the surrounding area, and all other related work in accordance with contract drawings, plans, and specifications hereinafter referred to and has been awarded this Contract for said work pursuant to award made August 8, 2014.
- 2. The Contractor will, at its own cost and expense, do the work required to be done and furnish the materials required to be furnished on said work in accordance with plans and specifications prepared by Edwards Engineering, Inc., bid numbered JCF-0107-14, bid date June 24, 2014, Project No. 12-149864, designated *Specifications for Cahoon Road Endwall Construction*, and strictly in accordance with the advertisement calling for bids, plans, specifications, blueprints, addenda, requirements of the City of Jacksonville, proposal of said Contractor, and award therefor (hereinafter collectively the "Contract Documents") now on file in the Office of the Chief of the Procurement Division of the City of Jacksonville, all of which

are hereby specifically made a part hereof by reference to the same extent as if fully set out herein for the total amount of SIXTY THOUSAND THREE HUNDRED SEVENTY-FIVE AND 00/100 DOLLARS (\$60,375.00), at and for the prices and on the terms contained in the Contract Documents.

- 3. On the faithful performance of this Contract by Contractor, Owner will pay Contractor in accordance with the terms and on the conditions stated in the Contract Documents.
- 4. This Contract and all amendments thereto may be executed in several counterparts, each of which shall be deemed to be an original, and all of such counterparts together shall constitute one and the same instrument.
