CONTRACT BETWEEN THE CITY OF JACKSONVILLE AND SOUTHERN RECREATION, INC. FOR INSTALLATION OF PLAYGROUND EQUIPMENT

WITNESSETH, that for the consideration and under the provisions hereinafter stated and referred to moving from each to the other of said parties respectively, it is mutually understood and agreed as follows:

- 1. That Contractor is the lowest and best responsible bidder for furnishing all labor, materials, and equipment and performing all operations necessary to provide and install PlayWorx custom concrete cow by GameTime at William F. Sheffield Regional Park, located at 3659 New Berlin Road, Jacksonville, Florida 32226, including, but not limited to, site preparation, clean up, and playground equipment installation, all in accordance with plans and specifications hereafter referred to, and has been awarded this Contract for said work pursuant to award made May 28, 2014.
- 2. The Contractor will, at its own cost and expense, do the work required to be done and furnish the materials required to be furnished on said work in accordance with plans and specifications prepared for the Parks, Recreation and Community Services Department, bid numbered CF-0067-14, bid date March 7, 2014, designated as "Bid Specifications for William F. Sheffield Regional Park Playground Development Project (Installation)," and strictly in accordance with the advertisement calling for bids, plans, specifications, blueprints, addenda, requirements of the City of Jacksonville, proposal of said Contractor, and award therefor

(hereinafter collectively the "Contract Documents") now on file in the Office of the Chief of the Procurement Division of the City of Jacksonville, all of which are hereby specifically made a part hereof by reference to the same extent as if fully set out herein, for the total base bid amount of ONE HUNDRED FORTY-THREE THOUSAND SIX HUNDRED FIFTEEN AND 00/100 DOLLARS (\$143,615.00), at and for the prices and on the terms contained in the Contract Documents.

3. On the faithful performance of this contract by the Contractor, the Owner will pay the Contractor in accordance with the terms and on the conditions stated in the Contract Documents.

4. This Contract and all amendments thereto may be executed in several counterparts, each of which shall be deemed to be an original, and all of such counterparts together shall constitute one and the same instrument.
