III. FAC/PAC Role Review

Cindy Laquidara gave an overview of the roles of the FAC and PAC Committees as prescribed in The Better Jacksonville Plan ordinance. Members of the Project Administration Committee oversee and advise on project details as they pertain to implementation and/or construction, including schedules, scope and resources. The Financial Administration Committee oversees the financial aspects of the projects, including advising and monitoring bond strategies, cash flows, revenue projections and other money management issues. The Mayor's Office is responsible for making final decisions regarding finances and projects.

A. Project Report

Mary Arditti

1. Transportation Program

Current transportation bonds remain \$401 million. Interest expense continues to run ahead of the model because the City bonded sooner than anticipated to take advantage of market conditions. The results is \$28 million compared to \$10 million model.

2. Infrastructure Program

Annual revenues are on target as projected. City had a \$153 million variable-rate bond issue on September 15.

3. Revenue Trends

Trends are essentially consistent with previous years. Spending is down but is expected to increase around the holidays. Expected funds from the state have not yet been received.

4. BJP Financial Summary Report

Per Cindy Stover's request, Ms. Arditti asked for suggestions from the FAC regarding improvements to the reports that may be necessary/warranted. Sales tax revenue is under projections approximately \$10 million. Issue bonds are good and the interest earned is approximately \$8.8 million.

5. JTA Matt Dominy

A majority of JTA projects are in their infancy, so budget numbers reported reflect this fact. Out of the \$763 million budget, there is a balance of \$418 million. On the transportation side, out of \$792 million, \$34 million has been expended.

B. Financing Update

1. BJP Infrasturcture SWAP

The yearly financial audit is underway. Committee discussed pros and cons of conducting both a program and financial audit yearly, given the status of the major vertical projects. Mr. Westbrook will look closer at the audit issue and provide recommendations by next meeting date.

- Softball complex is 80% complete
- Alberta Hipps has agreed to take over the leadership of the private fundraising for barns
- SMG is assisting the private fundraising group

JEA Ed Dendor

- Cecil Commerce Center infrastructure work is progressing along well
- Wastewater will be complete in December
- Water and sewer for Equestrian Center is 30% complete
- Four road projects under construction
- Septic Tank report provided by Carol Smith
 - (1) Pernicia complete
 - (2) Murray Hill B under construction Murray Hill B (4&5) – project start has been delayed due to the number of other projects already under construction
 - (3) Scott Mill Phase 1 & 2 on hold
 - (4) Glynlea Phase 1 on hold; Phase 2 under construction
