Preservation Project

PROJECT DESCRIPTION	The Preservation Project was launched in January 1999 as a \$312 million land acquisition initiative designed to manage growth, preserve environmentally sensitive land, improve water quality and improve access to the city's natural areas. The city initially committed \$21 million to the program. State, federal and private funding partners provide the remainder. The funding structure has been put in place and the remaining acquisitions have been identified, with preliminary assessments started, to ensure a successful outcome for this initiative.

MILESTONES

- 20,000 acres have been acquired, 31 square miles, creating one of the largest urban park systems in the country.
- \$88.5 million has been spent with funding partners over the last 2 ½ years, \$10 million below appraisal an average of 11% below appraised values.
- A program management firm has been hired to manage this land and master plan public access and recreational use of these passive parks.
- Currently, the three main focuses of the Preservation Project are:

 Complete land acquisitions for the Timucuan Ecological and Historic Preserve and Pumpkin Hill Creek Buffer Preserve, which will create an urban park area of nearly 100 square miles;

2) Plan for a greenway that joins neighboring counties and connects major state and federal acquisitions to preserve a natural corridor of 50 to 100 square miles across North Florida;3) Create passive urban parks that are tracts of natural areas, ranging from 26 to 2000 acres, that are located in heavily developed areas.

	Better Jacksonville funds complement existing resources aimed at creating a showcase park system in Jacksonville. Since 1995, the City of Jacksonville has allocated \$73 million to improve its park system.

JEA - Septic Tank Remediation July 24, 2001

PROJECT SCOPE	\$75 million
PROJECT DESCRIPTION	Under The Better Jacksonville Plan, JEA is phasing out septic tanks in six areas of the community that have been declared sanitary nuisance areas by the Duval County Health Department and the City Council. These are all areas where leaking septic tanks are polluting the St. Johns River or tributaries to the river.
	Drainage improvements will also be addressed in the six identified areas. The following schedule has been adjusted to allow construction concurrently.

Clean up of Contaminated Sites July 24, 2001

PROJECT SCOPE	\$25 million
PROJECT DESCIPTION	The United States Environmental Protection Agency (EPA) is overseeing the remediation of four Northside sites: Bethune Elementary, Lonnie Miller Regional Park, Forest Street and Emmett Reed Park. The Florida Department of Environmental Protection (FDEP) is overseeing the remediation of the Clydo Road site on the Southside.

MILESTONES	More than 5,000 water and soil samples have been taken on the Northside sites. The EPA has insisted on more tests before the clean up begins. These tests will push back the clean up of the Northside sites by one year. Clean up is now expected to begin in the summer of 2002. The length of the clean up time depends upon the method the EPA will choose.
	The FDEP has approved the testing plan for the Southside site. The city's consultant is expected to complete water and soil sampling by the end of 2001, unless ordered to do more. Based upon those results, the city will propose a clean up plan to the FDEP. Completion of the project depends upon the method chosen.
CLEAN UP METHODS	In all the ash sites, a number of clean up methods could be considered by the regulatory agencies. In some cases, exposure may be limited by fencing off a contaminated area. In other cases, the best solution may be to excavate the pollution and haul it to a toxic waste landfill. Both regulatory agencies will review a wide range of remediation options to determine the best solution.

Northwest Jacksonville Economic Development Fund

PROJECT DESCRIPTION	The Northwest Jacksonville Economic Development Fund will help steer growth and improve infrastructure to support development north and west of the river. Although the Fund has been in place since 1986, its impact has been sporadic. Through The Better Jacksonville Plan, \$25 million has been committed to support the goal of working as a catalyst for economic development with the target area, thereby, creating employment opportunities and providing much needed retail, commercial, and entertainment venues for area residents.
MILESTONES	Five major recommendations define the strategy of achieving the stated objectives. The following revised criteria and proposed changes are expected to be presented by Executive Order to the City Council for final approval this summer:

- the Business Infrastructure Grant (BIG) Program focuses on infrastructure needs for development and business growth targeting large businesses;
- the Small Business Development Initiative is a revolving loan fund that is defined by the ability of each participating business to repay;
- the Façade Program offers grants to improve the outward appeal of small businesses;
- the ACE Program, Assistance to Contractors and Entrepreneurs, provides technical assistance to businesses to help them to become certified vendors for the city, obtain access to capital and help meet the vast labor needs. Although ACE cannot be funded through The Better Jacksonville Plan, it is an important component to meeting the commitment of minority participation to the maximum extent of the law for Better Jacksonville projects through alternative funding.
- the Large Scale Economic Development Program will focus on major development and expansion projects by assisting major projects for up to \$4 million.
