The Better Jacksonville Plan Executive Summary

July 9, 2002

Sports and Entertainment Arena

• Project is on time and on budget.

Baseball Park

• Design is expected to be complete by Summer 2002 and a dedication ceremony is expected in Spring 2003.

Main Library

- Salvage of significant architectural elements is under way.
- Interviews for the Construction Manager were held July 8, 2002.

Regional and Branch Libraries

• Library Board of Trustees approved adjusted completion dates on eight branch libraries.

County Courthouse Complex

• Mayor John Delaney accepted the Professional Services Evaluation Committee's recommendation to enter into contract negotiations with Cannon Design for a new county courthouse complex, as a result of the design competition.

Street Resurfacing

• More than 650 miles have been resurfaced to date.

Neighborhood Sidewalks

• More than twenty-five miles of sidewalks have been constructed to date.

Roadway and Infrastructure Improvements

• A project status report is attached with scheduling information.

Preservation Project

• Development for public access and amenities will begin on Castaway Island and Camp Milton properties this summer.

Neighborhood Park Improvements

- There are 104 Better Jacksonville Plan park projects in the process.

Environmental Clean Up of Contaminated Sites

• Work to establish a plan for clean up of identified sites is continuing with the EPA and FDEP.

Cecil Equestrian and Recreation Complex

- Groundbreaking ceremony is scheduled for **September 5**th and marks the two-year anniversary of voter's approval of The Better Jacksonville Plan.
- An additional \$4 million of Cecil Field Roadway and Drainage funding will be used for infrastructure that will help support this project.

OVERVIEW

TRANSPORTATION PROGRAM

- For the seven-month period from October 2001 to April 2002, the city received \$33.2 million in sales tax revenue and \$3.8 million in proportionate share gas tax.
- Revenue is on target with the original cash model.

INFRASTRUCTURE PROGRAM

- For the seven-month period from October 2001 to April 2002, the city received \$32 million in sales tax collections.
- For the four-month comparative period of January 2001 to April 2001 and January 2002 to April 2002, there has been a 10.12% increase in revenues.

PROGRAM MANAGEMENT STATUS

 Development for public access and amenities will begin this summer on Castaway Island Preserve on San Pablo Road and Camp Milton Historic Preserve on Halsema Road.

- The Thomas Creek Preserve boat ramp opened before Memorial Day. City Council has appropriated \$100,000 for repairs and renovations at the boat ramp.
- Repairs to the air conditioning and bathrooms are nearly complete at the Palms Fish Camp. A redesign of the facility is under way.
- The Preservation Project closed on another 529 acres of property at Thomas Creek and at the Otis Road Trailhead. In addition, the Preservation Project closed on another 3,143 acre tract, known as the Monticello Wildlands.

PRESERVATION PROJECT STATUS

- City Council approved seven land acquisitions June 11, totaling nearly 10,000 acres.
- If the Preservation Project successfully closes all of the projects, the land acquisition total will exceed 33,000 acres, far exceeding all goals set at the program's outset in January 1999.

The Better Jacksonville funds complement existing resources aimed at creating a showcase park system in Jacksonville. Since 1995, the City of Jacksonville has

allocated \$73 million to improve its park system.

JEA - Septic Tank Remediation

PROJECT DESCRIPTION

Under The Better Jacksonville Plan, JEA is phasing out septic tanks in six areas of the community that have been declared sanitary nuisance areas by the Duval County Health Department and the City Council. These are all areas where leaking septic tanks are polluting the St. Johns River or tributaries to the river.

As part of The Better Jacksonville Plan, drainage improvements will also be addressed in the six identified areas. The following schedule has been adjusted to allow construction concurrently.

Environmental Clean-Up of Contaminated Sites

July 9, 2002

- U.S. Congresswoman Corrine Brown and U.S. Senator Bill Nelson have pledged to attempted to secure \$25 million in federal funding to match the \$25 million in The Better Jacksonville Plan for the clean up of contaminated sites.
- To date, the City of Jacksonville has encumbered \$920,000.
- Decades ago, municipal solid waste was incinerated at several sites in Jacksonville and ash from the incinerator was disposed of at several additional sites. Numerous studies and assessments have been conducted and the main contaminant in the incinerator ash appears to be lead.
- The City of Jacksonville is currently working closely with the United States Environmental Protection Agency and the Florida Department of Environmental Protection to test the sites, determine the extent and type of contamination and to develop a clean up plan.

Northwest Jacksonville Economic Development Fund

PROJECT STATUS

NWJEDF activity is summarized below:

- Hope Plaza is a commercial mixed-use development consisting of a 60,000 sq. ft. office building and 32-acre site. The developer is moving forward with development of a PUD for the site.
- Moncrief Plaza will be a 24,000 sq. ft. retail and commercial center located on Moncrief Road in the 29th and Chase Intensive Care Neighborhood. Demolition has been completed and bids for construction are being accepted.
- United Optical relocation from the Cathedral area to LaVilla is under way.
- Funding for Harmony Dental for infrastructure related to new construction of an office building in LaVilla pending City Council approval.
- Rehab of the One Metro North building, a commercial development located at 21st and Main Street, is currently under way.
- There are 15 façade renovations currently under contract. Over 100 applications have been approved.
- Projects approved by NWJEDF Advisory Committee include SYSCO and Hair Depot.

Efforts are ongoing to develop implementation strategies for ten targeted corridors. Action items to be completed during the fourth quarter of this fiscal year include completion of a market analysis to identify businesses to target, development of marketing materials, continuation of community outreach efforts and working with economic development partners to identify additional resources and technical assistance providers.

CHALLENGE

The majority of inquiries received to date have been for working capital. As the BJP funding can only be used for capital expenditures, identifying other funding sources is critical to our ability to provide assistance to small businesses.
