#### VII. Committee Reports

#### A. Community Relations

Commissioner Dennis Wade, Committee Chair, reported that Commissioner Parvez Ahmed will be managing the Civil Discourse Project. In his absence, Charlene Taylor Hill, Executive Director, stated she attended a meeting with Michael Boylan, President, WJCT; Gary Saltsgiver, Facilities Marketing Director, WJCT; Frank Denton, Editor, Florida Times-Union and Commissioner Parvez Ahmed, Associate Professor, University of North Florida (UNF) to further discuss the project. The Florida Times-Union will host the on-line dialogue through its website; the JHRC will supply the issues and questions for the on-line website; WJCT will provide the video televised presentation and UNF will provide website back-end academic support (analyzing data obtained during comments on the website.)

Commissioner Dennis Wade met with Sheriff Rutherford to discuss the perception of the Jacksonville black community that they are not being treated fairly by the police, (as reported in JCCI Race Relations Progress Report. The Sheriff has agreed to establish a committee, including members of the community, to help address this issue and asked Commissioner Wade to join the committee and assist in finding other members. After further discussion, it was agreed that the Community Relations Committee would develop question to ask the Sheriff and invite him to attend a committee meeting.

Commissioner Yvonne McClain, Committee Chair, reported that the Employment Committee reviewed the meetings it had with Work Source and JTA regarding barriers to employment. In addition, the committee would like to meet with the Jacksonville Chamber of Commerce. The goal is to have the three agencies meet to discuss ways to remove the current employment barriers.

## D. Special Legislative Committee

Commissioner William "Casey" Bulgin, Committee Chair, stated the committee reviewed the resolution approved in November 2011 to recommend amending City ordinances (Employment, Housing and Public Accommodations) by adding sexual orientation and gender identity as a protected group. The resolution was signed by Commissioner Michael Wachholz, Chair, and has been delivered to a representative in the Mayor's office.
