Ed Callao called the meeting to order at 6:07 p.m.

I. Pledge of Allegiance

Introductions made around the room. Ed Callao thanked Grace Pettus from the Mayor's Office for attending the meeting. Ms. Pettus used to work for Senator Bill Nelson and now is the Assistant to Michelle Barth and Betzy Santiago.

III. Guest Speakers

Wayne McGovern- Equal Employment Access Specialist

Mr. McGovern will be rescheduled for a future meeting.

John Braun - City of Jacksonville, Victim Services Center, 403 West 10th Street

Mr. Braun stated that the Victim Services Center provides assistance to victims of crime and help with stabilization. Advocates will assist victims of a violent crimes and meet them at the hospital. Rent, food, and medication assistance is available up to \$2,000 over a period of time. Victims can also receive mental health counseling. Victim Services Center collaborates with the Jacksonville Sherriff's Office and Hubbard House.

The Sexual Assault Center conducted 270 exams last year. The Rape Crisis Hotline is available 24/7 and the number is (904) 358-7273. Flyer attached.

Mr. Braun asked the Board to forward the Victim Services Center information to their various countries they represent.

Discussion was made in regards to the language barrier for victims to get assistance. John Braun stated as part of the VOCA grant the Victim Services Center has translation services available through the City but needs more interpreters to able to reach more in the community. Jay Gogaliya commented that the information should be in their language, so it would be something they recognize. Mr. Braun agreed and said that volunteers would be needed to help in this process. Do In Kim stated that many people do not report the crimes because the 911 operators and the police do not understand the victims language.

Grace Pettus, Sophal Archard, Ed Callao and Rajat Sharma suggested outreach opportunities for the Victim Services Center at several events.

Ed Callao asked John Braun to discuss to be a speaker at the Winter Forum

IV. Approval of Minutes

A motion was made to table the October minutes by Jay Gogaliya and Radwan Chowdhury seconded and the motion passed without discussion.

V. <u>Committee Updates</u>

Nomination/Membership - Jay Gogaliya

Finance – Bala Govi

Bala Govi presented the Finance Report to the Board. Radwan Chowhdhury made a motion to accept the report, Mai Keisling seconded with changes to the memo field on the Finance Report, and the motion passed without discussion. Laura Davis, Assistant to the Liaison, reminded the Board that funds needed to be raised for upcoming events.
