

### Call to Order

The meeting was called to order at 4:02 p.m. by Chair Alfreda Telfair.

### **Moment of Silence**

### **Roll Call**

Secretary Melissa Scites took the roll. There were no Proxy Pool members available to be called to the table; a quorum was declared.

### **Approval of Minutes**

A motion was made and seconded to accept the November 21, 2013 Minutes as presented. The motion was carried.

### **Administrative Agency Report**

Program Manager Deidre Kelley presented the Agency Report. Because of the recent challenges with the implementation of the Affordable Care Act and enrolling people into the health care marketplace, our Eligibility Sub-Committee is requesting that the Jacksonville Planning Council review a proposed policy for health insurance premium assistance. Funding for health insurance premium assistance will come from the outpatient medical care and pharmaceutical funds that clients enrolling in health insurance will no longer need for care. The Priority and Allocations Committee will look at the funding next month, and should have a better idea at that time as to how the funding among these categories can be reallocated.

Congratulations to Planning Council Secretary Melissa Scites of UF Health, who was named Trailblazer of the Year by the World AIDS Week Committee. Congratulations are also extended to the AIDS Program Office staff for winning Provider Agency of the Year and to committee member Zane Urbanski for winning the Vicki Hitzing Waldron Award. All of you are winners every day, and the Administrative Agency is happy to see you recognized for all your hard work in the community.

Over the past couple of months I've been hearing some positive things about the PLWHAA Committee. The momentum seems to have kicked up a degree or two. As a reminder, PLWHAA Committee meetings are open to the public and anyone can attend and join.

### **Committee Reports**

PLWHAA Justin Bell

The committee met December 12 and there was a lot of new energy and great dialogue during that meeting.

<u>Eligibility</u> Pat Sampson

The sub-committee met on December 12 to look at eligibility criteria for health insurance premiums and co-payment assistance next year. Initial estimates are anywhere from 290 to 500 Ryan White clients who might need some type of assistance with their premiums or co-pays. Motion made by Heather Kilpatrick, seconded by Justin Bell to approve the Eligibility Criteria for health insurance premiums and co-payment assistance beginning March 1, 2014. After some discussion, the motion was carried.

Nominating Antoinette Turner

During their December 13 meeting, the committee interviewed four candidates and are recommending all four to the Planning Council. Three of the candidates are for mandated categories on the Planning Council, and the fourth is for the Proxy Pool.



### Call to Order

She reminded members that when they commit to attending or participating in an event, they should follow up with that commitment. Nathaniel Hendley stated that he wanted the committee to review their Goals again and see where we are. Recruitment for this committee is on-going and very important. He reminded the members that the Planning Council will support us, but we have to have a plan in place.

Torrencia requested that some type of chart be made for 2014, showing all the PLWHAA committee members' names and giving credit, perhaps a gold star, by that member's name for any events or work that the member did during the month.

Justin reminded the group that there is a way for everyone to get involved, regardless of transportation or mobility or financial hurdles. An example is being an advocate for funding; all a person needs is a telephone or Internet access. Just a simple phone call to your elected official can help with the cause. Getting to Zero is one of President Obama's goals for HIV, and the goal date is 2015; that's just one year away!

Torrencia informed the members of the national strategy, which is high and tight prevention. This is divided into four components: (1) HIV testing, (2) condom distribution, (3) prevention for positives, and (4) policy or capacity building.

Justin talked about the Florida AIDS Network (FAN), which meetings monthly via telephone and/or the Internet. Date and information about the next meeting will be sent out during an upcoming Email blast.



• Establishing eligibility criteria for health insurance premiums and co-payment assistance for 2014:

Individuals with incomes between 138% and 400% of the federal poverty level and who have no health insurance are required to enroll in an insurance plan between October 1 and December 23, 2013 in order to have coverage by January 1, 2014. In our TGA, 10% of our clients that we currently serve, or 460, are eligible to enroll in the ACA marketplace. It's anticipated that many of these clients will need assistance in paying their premiums and their medical office visit co-pays. An ACA Cost Analysis for FY 2014 has been prepared and is attached to these minutes. At this time, the committee only needs to establish an eligibility criteria in anticipation of our needs going forward.

Following the committee's review of the attached Eligibility Criteria, Heather Vaughan **moved that** the committee present the Eligibility Criteria to the Planning Council for their approval. Zane Urbanski seconded the motion, which was then voted on and passed.

# Jacksonville Area Ryan White CARE Network Eligibility Criteria Health Insurance Premium Assistance Program

Health insurance services assistance is the provision of financial assistance paid on behalf of eligible individuals living with HIV to maintain continuity of health insurance or to receive medical benefits under a health insurance program. This service is available for purchasing health insurance that provides comprehensive primary care for low income clients that provide a full range of antiretroviral (ARV) medications. This service also pays co-payments on behalf of eligible clients. As such, there are two types of assistance under this service category: **Health Insurance Premium Assistance**, and **Medical Visit Co-Payments**. Federal funding under this service category may not be used to supplant existing federal, state, or local funding for health Insurance Premium and cost-sharing assistance.

# I. Health Insurance Premium Assistance

Health Insurance Premium Assistance is a Ryan White Part A funded program that provides assistance to clients who already have private health insurance but are not financially able to pay the premiums. This program does not provide new health insurance policies to eligible clients; it allows them to continue with their current insurance carrier. This program does not include coverage of disability or life insurance payments. The maximum amount of assistance a client may receive each month is \$125.00 (one hundred twenty-five dollars) towards their monthly insurance premium. Assistance will be based on a sliding fee scale according to income. Assistance may also be provided to facilitate conversion of group coverage (i.e., COBRA) to an individual insurance policy.

The Ryan White Part A Program supplements health insurance policies purchased through the health insurance marketplace. Ryan White Part A Program support depends on the amount allocated to this service and the amount of funds available at the time of the request. This service description covers only those services paid for by Ryan White Part A funds.

# Jacksonville Area Ryan White CARE Network Eligibility Criteria

### Health Insurance Premium Assistance Program

- **A. Program Operation Requirements:** Providers may not reimburse clients directly for their premium expense.
  - Providers are required to inform clients of their rights regarding insurance coverage and to ensure they use their private health insurance to obtain medical care, prescription drugs, and other treatment. Clients will not be eligible for Ryan White Part A-funded services if such services are available under their existing health insurance, private or public.
- **B.** Rules for Reimbursement: Providers will be reimbursed for dollars expended per insurance premium.
- **C.** Additional Rules for Reporting: Monthly activity reporting for this service must be in dollars expended per insurance premium per client.
- D. Special Client Eligibility Criteria: Clients receiving Part A assistance for this service must also: 1) have active health insurance under a group, individual, or COBRA policy; and 2) be willing to sign all required forms and provide all requested eligibility information. A complete financial assessment and disclosure are required.
- E. Additional Rules for Documentation: Providers must maintain proof that the insurance policy provides comprehensive primary care and has a formulary with a full range of ARV medications. Providers must also issue an annual assurance that funds were not used to cover costs of liability risk pools or social security.

# Jacksonville Area Ryan White CARE Network Eligibility Criteria

### Health Insurance Premium Assistance Program

### II. Medical Visit Co-Payments

- A. Program Operation Requirements: This type of assistance is available to <u>privately</u> insured clients who are required to pay a co-payment for their primary care office visits. The medical provider will bill the insurance carrier for a portion of the cost of the visit and Part A will cover the remaining portion of the cost, not to exceed \$25.00 per visit, for clients who meet Ryan White Part A Program eligibility criteria. A complete financial assessment and disclosure are required.
- **B.** Rules for Reimburse: Providers will be reimbursed for dollars expended per co-payment.
- C. Additional Rules for Reporting: Monthly activity reporting for this service must be in dollars per co-payment per client.
- D. Additional Rules for Documentation: Providers must maintain proof that the insurance policy provides comprehensive primary care. Providers must also issue an annual assurance that funds were not used to cover costs of liability risk pools or social security.


Please Note: Medical case managers and insurance enrollment specialists must work with clients to explore in a diligent and timely manner all insurance options and evaluate the client's best option to ensure that deductibles and co-payments are reasonable. For Medicare Part D recipients, any client whose gross household income falls below 135% of the 2014 Federal Poverty Level (FPL) must be enrolled in the Low Income Subsidy (LIS) Program. In addition, for Medicare Part D recipients, any client whose gross household income falls between 136% and 150% of the FPL must be enrolled in the ADAP Wrap-Around Pilot Project (AWAPP). For Medicare Part D recipients, any client whose gross household income falls above 150% of the FPL or does not qualify for the LIS and who fall into the "donut hole," must be referred to the ADAP Program.

- James Bernert: Mr. Bernert is retired and is a volunteer with Lutheran Social Services' Food Bank. He is applying for the Proxy Pool.

 Following the interviews, Justin Bell made a motion to recommend to the Planning Council Kendall Guthrie for Part 'D', Heather Vaughan for Community-Based Organization, and Torrencia Shiloh for HIV Prevention categories, and to recommend James Bernert for the Proxy Pool. Motion was seconded by Sharon Peterson. Vote was taken and motion carried.
