A motion was made by Sean Hatchett to approve the Consent Agenda Items 1-4. Brady Rigdon seconded the motion which passed unanimously.

NEW BUSINESS

1. John Keane, Executive Director-Administrator told the Advisory Committee that the Board of Trustees followed their recommendation to deny benefits to Cordelia Cook and the Final Order would go to the Board at their next meeting.

He gave them an overview of the actions of the Task Force for Pension Reform. Dr. Chester Aikens had a heart attack leaving the last meeting in which he had moved to drop Defined Contribution consideration. Randy Wyse and Mark Treglio performed CPR, however Mr. Aikens suffered a 2nd heart attack at the hospital and passed away.

The Task Force recognizes the Settlement Agreement is in place until 2030. They have recommended no on Pension Obligation Bonds and property swaps with the City. They recommend that the City sell the property, getting it back on the tax rolls and giving the money to the Fund. They also recommend that taxes be raised by 2 mils and support alternative investing and Ordinance 66. They also say the City should not declare bankruptcy.
