Per your request, and in accordance with Ordinance 2016-521-E, below is a summary of the Jacksonville Waterways Commission activities for the 2016-17 year for the reporting period of July 1, 2016 through June 30, 2017.

Summary of Commission Prior Year Activities

The Chair of Jacksonville Waterways Commission, Council Member Aaron Bowman implemented the following new subcommittees:

- 1) Non-Motorized Activities Subcommittee (Paddleboards, Kayaks, canoes, etc.)
 - Subcommittee Members: Anna Lopez Brosche-Chair, Steve Swann Vice Chair, & Ray Pringle, Marshall Adkison
- 2) Entertainment Subcommittee (Restaurants, Family venues, Pubs, etc.)
 - Subcommittee Members: Gary Anderson-Chair, Aaron Bowman Vice Chair, Jim Suber, Garrett Barket & Penny Thompson
- 3) Sports Entertainment Subcommittee (Fishing, water skiing, jet ski, etc.)
 - Subcommittee Members: Jim Love-Chair, Jill Haskell- Vice Chair, Ralph Hodges, Marshall Adkison

The three subcommittees are charged with conducting a thorough review and investigation of potential opportunities to activate the St. Johns River and Downtown, and to make recommendations on their findings to the full Commission. The subcommittees should meet at least monthly to establish an inventory and strategic plan of actions and milestones to be complete then presented at the Jacksonville Waterways Commission meeting on April 12th, 2017.

The Jacksonville Waterways Commission meets every second Wednesday of the month. The current positions are filled and there have been no vacancies in this past annual reporting year. The Commission is charged to formulate an overall plan for dealing with any problems that exists the St. Johns River and Duval County tidal waters and devise methods of developing future uses of those waterways.

The Commission serves as the Duval County committee to review rules proposed by the Florida Fish and Wildlife Conservation Commission governing speed and operation of motorboats to protect manatees. The Jacksonville Waterways Commission acts as a coordinating agency and specialized advisor for governmental units and for programs and activities affecting the improvement, development and protection of the St. Johns River and all tidal waters in Duval County. In the course of its work, the Commission conducts research, collects and analyzes data and prepares maps and charts.
