- Ordinances
 - Official Legislative Action or regulation and enforceable as law
 - Examples
 - Appropriations
 - Penalties
 - Taxes, fees, or any other charges
 - Impose mandatory duties or obligations
 - Contracts
 - Necessary to amend previous ordinances
 - Enacted

Types of Legislation

- Resolutions
 - Matters of city administration
 - An expression of a temporary, advisory or exhortative character
 - Appointments
 - Adopted

Bill Summary: The ordinance appropriates \$470.108.94 (\$100,000 from Designated Contingency for the Supervisor of Elections and \$370,108.94 from the General Fund/General Service District Fund Balance) to fund the general election in May; the ordinance recognizes that the City will pursue State reimbursements for the Special Primary Election in December 2014 and Special General Election in February 2015; it provides for a reverter of unused funds to the General Fund; requires approval of two-thirds of the Council Members present, pursuant to 106.215(B), Ordinance Code.

Background Information: The purpose of the appropriation is to provide funding for the general election in May. The Supervisor of Elections Office paid for the expenses of the Special Primary Election in December 2014 and the Special General Election in February 2015 ordered by the Governor as a result of a vacancy in the State House District 13 office. The Supervisor of Elections intends to seek reimbursement from the State for the expenses of these special elections, but will not have the funds available for use in the May General election.


