
# Message from the President and Diocesan Director


I believe this kind of compassion and love is given to our needy brothers and sisters every time they come to Catholic Charities.

Backpack Program assisted low income, food insecure children by giving them backpacks filled with nutritious food for weekends and holidays.




## 93,677 INDIVIDUALS


