Chair Jay Fant called the meeting to order at 1:05 p.m. followed by the invocation and pledge.

Member Present: Senators Bean and Gibson; Representatives Byrd, Davis, Fant, Fischer and Yarborough.

A quorum was present. Delegation members introduced themselves and their staff members.

Chair Fant opened the floor for nomination of Chair of the Delegation and recognized Representative Fischer, who nominated Senator Aaron Bean. There being no further nominations, Senator Bean was elected unanimously as Chair.

Representative Fant thanked everyone for all their work and praised their eloquence; he then passed the gavel to the new chair, Senator Bean. Chair Bean presented Representative Fant with an award for service of chair.

Chair Bean opened the floor for nominations for Vice Chair of the Delegation and recognized Representative Yarborough, who nominated Representative Fischer. Senator Gibson then nominated Representative Davis for Vice-Chair. There being no further nominations, a voice vote was held with 5 votes in favor of Representative Fischer and 2 votes in favor of Representative Davis. Representative Fischer was elected as Vice Chair.
