The subject contract was awarded with an effective date of August 1, 2018, to procure caretaker and facilities maintenance support for Cecil Commerce Center over a four-year period. The contract provides for options to extend the contract for 2 additional 1-year periods.

This amendment is to exercise the first of two available one-year extensions and to modify the scope of work to reflect the required work to be completed from August 1, 2019 through July 31, 2020. The City requested a revised work plan for the period August 1, 2019 through July 31, 2020 and received a proposal from VT Griffin Services by the attached Exhibit "A". Negotiations were conducted to establish costs associated with the proposed work plan.

OED requests authorization to increase the maximum indebtedness of the subject contract by \$2,851,480.00, to a new maximum indebtedness to the City of \$4,692,078.00.

Accordingly, this is to recommend the City amend the subject contract with VT Griffin Services as follows:

- 1) The costs for work under subparagraphs 3.1.1, Management and Maintenance/Caretaker Support Services are in the amount of \$2,851,480.00, as proposed by VT Griffin Services, Inc. written cost proposal dated April 5, 2019.
- 2) All other terms and conditions remain unchanged
- 3) Exhibit "A" is incorporated as part of the Contract.

The contractor, VT Griffin Services, has exceeded the overall established MBE goals for performance and continues to provide outstanding service under the contract. Additional funds are budgeted to effect this proposed change to the contract.
