Proposals have been received and graded for the replacement contract requested under RFP -06-18; pending approval of the matrix and contract negotiations. Execution of this contract is anticipated within the next 120 days. The current contract held by RS&H, Inc., contract # 3140-32, for these services expired April 30, 2018. It is beneficial for the City to be able to utilize their services for Miscellaneous Dredge and Waterway Infrastructure until the replacement contract can be executed. There is no rate increase associated with this amendment.
