Program Summary:

The Neighborhood Accountability Board (NAB) serves as a dedicated diversionary program designed to provide consequences and services for youth, ages 10-17, issued a juvenile civil citation in some of Duval County's highest crime zip codes. The NAB represents a community based decision making process aimed at repairing harm brought on by crime. This process incorporates Restorative Justice principles. Upon completion of all assigned tasks, the Youth receives a Certificate of Completion from the NAB and no charges are filed and no delinquency record is ever created, thus not hindering the Youth from opportunities related to college admissions, military recruitment and employment in the future. The goals of the NAB are: to provide the victim and community the opportunity to converse with an offender in a safe and productive manner, to provide an opportunity for an offender to take responsibility and make amends, to provide community/citizen ownership of the justice system, to provide a timely, community response to repair harm and MOST IMPORTANTLY, to give youth the opportunity to avoid criminal prosecution for a first time misdemeanor offense.

Successes:

- A fourth NAB is in place to begin at the end of the month in Arlington. Training has already occurred at Terry Parker High School. A mock NAB occurred on 10/13/15. The first active case is scheduled for a hearing on November 10, 2015. The new Board met on 10/27/15 for more training and to assign roles within the Board. A scheduler has been identified as well as a person to collect client assignments. Community Service sites were discussed and Board members will be contacting local agencies and businesses to find out if they are amenable to youths completing their hours at their establishments.
- 2. This writer met with the local Full Service School Director to discuss the expansion of extra zip codes into the established NABs. Tentatively, we plan to incorporate the Sandalwood area of Jacksonville into the Beaches NAB after January 1, 2016. A meeting with icare is scheduled on 12/9/15 to discuss in more detail.
- 3. On 10/22/2015, this writer provided community outreach and training to the San Marco Rotary Club. As a direct result of this, this writer has been asked to speak at a Luncheon for Youth Leadership on November 12, 2015.
- 4. On October 22, 2015, the Teen Court staff attended an all-day training titled: Cross Cultural Communication Training: Building Communication Skills for a Diverse Environment.
- 5. iCare, a NAB stakeholder recently met with Sheriff Williams and he has renewed his promised to encourage the issuing of civil citations to juveniles! If this occurs, NAB referrals will continue to increase!
- 6. Referrals have increased! As of 11/5/15, there are 5 new cases on the schedule for November. Likely more will be added in the next 2 weeks.
