Enforcement of Affidavit

For the following violations, a citation may be issued on one affidavit with video recording of the alleged violation, or with two affidavits from **two** unrelated adult witnesses from different households, or on an officer witnessing the violation:

462,203

Cruelty to animals

462.301

Failure to remove and dispose, immediately of fecal matter

462,302

Allowing an animal to make objectionable noise continuously for a period of 20 minutes or more with individual interruptions of less than 20 seconds.

462,303

Allowing an animal to be at-large

For the following violation, a citation may be issued on at least one sworn affidavit accompanied with video recording of the alleged violation, from two or more adult witnesses from different residences, *or* an officer witnessing the violation:

Permitting an animal to damage someone else's property or biting.
