Over the past few months, members of the St Johns River Report Team has met with the EPO committee and EQD staff to discuss plans for the upcoming series of reports and to understand potential changes discussed. They took input from the committee and staff and came up with a final funding request that was submitted for consideration.

The committee reviewed a funding request from the river report team in the amount of \$311,863 for the Twelfth, Thirtenth and Fourteenth editions of the State of the River Report .

After a review of the request, and after several meetings with the team, the JEPB Education & Outreach committee determined that continued funding would be of substantial environmental benefit and is a worthy use of Environmental Protection Trust Fund dollars and recommends seeking City Council approval of the \$311, 863 request with the following conditions:

- 1. The \$311,864 request be funded as presented
  - a. Payments in the amounts of \$99,443, \$103,880 and \$108,540
- 2. A waiver of Sections 111.755(f) and 360.602(f) Ordinance Code to continue funding of the State of the River Report.
- 3. Invoke an exception to Sec. 126.107(g) Procurement Code allowing the use of professional services of Jacksonville University
