CALL TO ORDER INTRODUCTIONS

LUCINDA SONNENBERG

Chair Sonnenberg called the meeting of the Jacksonville Environmental Protection Board (JEPB) at 5:03 pm. A quorum was established.

CHAIR STATEMENT

The Chair indicated that the meeting was a continuation of the variance reconsideration request.

PROCESS CLARIFICATION

Mr. Richardson shared that the meeting had been incorrectly noticed as an appeal hearing. He reiterated that it was indeed continuation of the reconsideration discussion. He asked members to declare any ex-parte communication they had received or participated in.

PRESENTATION BY STAFF

Mike Williams, EQD Air Branch, and Melissa Long, EQD Chief, shared an evaluation of communications to residents about early morning concrete pours, complaints received, mitigation measures currently implemented and proposed measures agreed upon by the contractor to be implemented.

Mr. Williams shared that going forward:

- > There are 4 remaining 3 am concrete pours.
- ➤ B&G will add 3 signs notifying residents of upcoming concrete pours.
- ARGOS and Sunbelt Rentals will retrofit vehicles/equipment with broadband backup alarms.
- Concrete mixer trucks will no longer be allowed to air off.
- Concrete pump trucks will no longer use a horn to signal the start and stop of pumping.

BOARD QUESTIONS / CLARIFICATIONS

Members expressed appreciation for the information and accepted the additional mitigation measures to be implemented. During discussion, EQD staff was asked to have Brasfield & Gorrie also communicate upcoming concrete pours schedule to residents of the Brooklyn complex as well as to 220 residents.

BOARD VOTE

A motion was made to deny the reconsideration request (Baker) and was properly seconded (Deck).

During discussion, Ms. Shirley expressed appreciation for the work of the staff and supports what is being proposed, however she could not support the motion to deny the request. Mr. Deck asked the staff for a commitment to update the Board at monthly meetings.

The motion was approved with a vote of 5-1 (Shirley).

PROCEEDURAL SUMMARY

Mr. Close stated that the JEPB had taken action to deny the variance reconsideration request and that the parties would be notified of the board action.

The meeting adjourned at 5:36 pm



Going Forward – Commitments from Brasfield & Gorrie:

- The concrete supplier, ARGOS, has committed to retrofitting 40 concrete mixer trucks with broadband (white noise) backup alarms within 45 days.
- Sunbelt Rentals (majority of rental equipment onsite) has committed to retrofitting the onsite equipment with broadband backup alarms within 30 days.
- Concrete mixer trucks will no longer be allowed to air off.
- Concrete pump trucks will no longer use a horn to signal the start and stop of pumping.

Summary

- Concrete pump trucks will no longer use a horn to signal the start and stop of pumping.

Conclusions

- EQD feels that the existing noise variance provides adequate tools to limit noise disturbance to the extent practical for this project.
- EQD will monitor the 6/29/2019 concrete pour (pump truck located on Jackson) to determine if additional noise mitigation measures are warranted.
- EQD will continue to monitor complaints and evaluate the need for any additional noise mitigation as construction progresses.
