- 3. Approval of the Previous Meeting Summary: February's meeting summary was approved by
- 4. Unfinished Business: None
- 5. New Business: CPAC Member Larry Solomon stated last year he submitted a letter to the Florida Department of Transportation (FDOT) through the CPAC regarding a bridge near US-1 and Richardson Road. The bridge needs to be elevated due to flooding. He requested to have a representative from FDOT to give an update on the request at a future meeting. CPAC Member Larry Solomon will send a copy of the letter to Jessica Denson.
- 6. Chairs Report: Chair Boyd shared a letter that was sent from the City of Jacksonville to the CPAC chairs with respect to the Northwest CPAC membership asking them to identify one priority capital improvement project request for each neighborhood within the boundaries of the Northwest District. These projects will be considered for inclusion in the proposed FY2022-2026 Capital Improvement Program (CIP) (subject to available funding). The deadline to return the Northwest recommendation list of capital improvement projects is May 21, 2021. Chair Boyd opened the floor to allow CPAC members to volunteer to be a part of the Northwest CIP Subcommittee; CPAC Members Larry Solomon, Elaine Billups, Roxanie Currier and Tyrona Clark-Murray volunteered. The CPAC members voted to have the Northwest CIP subcommittee meetings on March 22nd, April 5th, and April 19th at Lincoln Villa Senior Center, 7866 New Kings Road at 5 p.m. Jessica Denson will check on the availability of the building.

### 7. Subcommittee and Liaison Reports

- Land Use and Zoning Subcommittee: Roxsan Currier reported that LUZ Subcommittee
  members reviewed seven land use and zoning applications and suggested to oppose
  one application. The Motion is:
  - Denial of 2020-0745 address of application (PUD) Sunshine Organics and Compost, RE# 111121-0000.: This application seeks to rezone 10.92± acres of land from IL to PUD to allow for a solid waste/compost facility. The CPAC passed the motion to deny the application.
- TRUE Commission: Velma Rounsville reported that the Taxation, Revenue, and Utilization of Expenditures (TRUE) Commission met Thursday, March 4, 2021. The TRUE Commission had a discussion on monies the City of Jacksonville may be eligible to obtain from the new Coronavirus Recovery Act. The commission will investigate two bills introduced by the City of Jacksonville; 2021-100: \$100M appropriation for additional septic tank remediation and 2021-118: \$30M to supplement existing septic tank phase out work projects in the Beverly Hills and Christobel neighborhoods since funding is currently insufficient. TRUE Commission Chair will connect with CPACs that have membership vacancies on the commission.

- Municipal Code Compliance (MCCD): Brian Naples, Municipal Code Compliance Supervisor, introduced himself as the new supervisor for the Northwest District. In February, MCCD completed 1,484 inspections in the Northwest District. MCCD has a program called the Jacksonville Assistance and Relief Program (JAR), which provides abatement services at no cost to Jacksonville residents who qualify. If ticket is not resolved by appropriate department then the CPAC member should report the CARE ticket number to the CPAC. This allows the responsible department within the City of Jacksonville to address the issue before escalating it through the CPAC.

Jessica reminded CPAC members about the CPAC membership attendance requirements. She explained the following concerning unexcused absences:

Pursuant to Executive Order 2014-03 states any primary CPAC member, including Charter members and members appointed by City Council members, including alternates when requested to attend in place of the primary, who fail to attend three consecutive meetings of the CPAC without contacting the Neighborhood Coordinator, either by telephone or email prior to the scheduled CPAC meeting, shall be automatically removed from the CPAC.

- a. After the first unexcused absence, the Neighborhood Coordinator shall call the member and send an email (if applicable) to contact and encourage the member to attend the next meeting.
- b. After the second unexcused absence, the Neighborhood Coordinator shall call, email, and send a formal letter to encourage the member to return to the CPAC, but also to advise the member that the third unexcused absence will result in an automatic removal from the CPAC.

c. If a third unexcused absence occurs, that member will be automatically and immediately removed administratively from the CPAC. If that member returns to the CPAC, they will need to reapply as a new member.
