Call to Order/Verify Quorum: Chair Messer called the January 2020 GAB CPAC meeting to order at 6:30 pm. Rosemary Wesolowski verified that a quorum was present.

Approval of the Previous Meeting Summary: The November 2019 and December 2019 meeting summary was approved by the CPAC.

Presentation: Steve Long, Public Works, Chief of Right Away and Stormwater Maintenance informed the CPAC that the Right of Way and Stormwater Maintenance Division maintains all city-owned streets, sidewalks and drainage facilities; including 1,200 miles of ditches/outfalls, 1,200 miles of stormwater pipes, curbs, and catch basins. The Right of Way and Stormwater Maintenance Division completes the following jobs/repairs: pot hole patching and resurfacing; street sweeping, roadside ditch re-grading and minor piping (Stormwater Action Team; clearing drainage pipes and inlets; minor bridge repair and install and repair guardrails.

To complete these jobs, Mr. Long and his team rely on a variety of different pieces of heavy equipment. Mr. Long was showed a video that featured the new equipment that the Public Works Department has acquired; the video demonstrated how each piece of equipment operates. Equipment featured and later discussed was the Menzi Muck Excavator and the Vac-Con machine.

Several members of the CPAC asked Mr. Long questions about the requirements needed to have speed bumps installed. Mr. Long stated that this is a process that is handled by the Traffic Engineering Division, but he did confirm that a neighborhood/community is required to have a signed petition that has at least 75% of the home owners on the street in agreement to adding and maintaining the speed bumps. Elected Officials Report:

Joyce Morgan, City Council District 1- extended New Year wishes to all and announced that her next Council District 1 Town Hall Meeting will be held on Monday, January 27, 2020 at Jacksonville University (JU) at 6:00 pm in the Gooding Auditorium, 2800 University Boulevard North, 32211.

Council Member Morgan shared that she and Nathaniel Ford, Chief Executive Officer, Jacksonville Transportation Authority (JTA) drove City Council District 1 together and looked at various areas where concerns have been made by community members and to assess the public transportation needs of the community.

Council Member Morgan announced at the intersection of Arlington Road and University Boulevard North, a new WaWa gas station will be built; the GAB CPAC should see the LUZ application soon. Tom Bush Mazda will have a grand re-opening this week. The Arlington CRA Overlay seems to have everything in place and should move to the next phase.

Staff Reports:

JSO (Jacksonville Sheriff's Office) – Assistant Chief Chris Brown was pleased to share both violent crime and property crime was down 11.5% in Zone 2 the past thirty days. Burglaries to unlocked cars continue to be a problem. Everyone was encouraged to participate in the 9 pm Routine.

Jacksonville Public Library – Jackie Spiritas reminded the CPAC that library cards expire every three years. To renew your library card you must show proof of Duval County residence and apply in-person at one of our 21 library locations.

Jax Book Fest, an annual community event that brings together local authors and book lovers, will return to the Main Library Feb. 29, 2020, 10 am – 3 pm, with New York Times best-selling authors Brad Meltzer and Karma Wilson as keynote speakers. The event, which will celebrate its fourth year in 2020, will

feature more than 80 local authors of every genre. Authors can apply now for exhibit space at Jax Book Fest 2020 on the Jacksonville Public Library Foundation's website at www.iplfoundation.org/jaxbookfest.

Jacksonville Public Library and the American Association of Retired Persons (AARP) Foundation partner each year to bring FREE tax preparation to the community. JEA – Nancy Veasey introduced herself and informed the CPAC she was in attendance on behalf of Renee Goode. Ms. Veasey works in the Government Relations area at JEA and she is part of the team working on the new JEA downtown headquarter location. No construction details are available at this time. Ms. Veasy provided handouts on energy conservation tips for your home. Ms. Veasy stated that she was available for questions.

Neighborhood Municipal Code Compliance Division – Supervisor Gary Roberts announced in Zone 2 the Code Compliance teams worked 1239 cases in the past 30 days. Most of the cases are related to junk vehicles and set back violations. Mr. Roberts and his Code Enforcement team started a systematic inspection today in the Arlington Neighborhood; the inspection should be completed by the end of the week.

Planning and Development Department –On behalf of the LUZ Subcommittee chair, Connie informed the CPAC that the LUZ Subcommittee reviewed four LUZ applications. There was one application that the subcommittee decided to make a motion on.

AD-20-03 is an Administrative Deviation at 2521 Cortez Road and the subcommittee supported the Planning and Development Departments recommendation to deny the application. Eddi Parsons made the motion and Jerry Petoskey seconded the motion. After a brief discussion, the CPAC voted unanimously to approve the motion.

Council Member Morgan stated that she also had an update on the letter that the GAB CPAC sent in regard to having the utilities put underground at the Rogero/Arlington Road roundabout. Public Works will work with the contractor to place the utilities underground.
