Nikki Evans, Executive Council Assistant, At-Large Group 2 informed the CPAC that the Mental Health Offender Pilot Program (MHOP) has received funding and is a permanent program now (no longer a pilot program). Four program participants were a part of MHOP's first graduating class. The graduates are invested in turning things around for themselves and have moved into a group home environment where they will live independently. A trust fund for the Mental Health Offender Program has been established and will be available to accept funds/donations by the end of the year.

Staff Reports:

JSO – Lieutenant Terrell shared JSO crime statistics that reflect year to date numbers in the Zone 2 area: robberies are down 25%, car jackings down 7.14%, robberies to businesses down 50%, aggravated batteries were down .95%, burglaries to residents were down 17.3%, burglaries to businesses were down 39.5%, auto thefts were down 17.8%, auto burglaries were down 35.79%, grand theft was up 9.88%, petty theft to businesses were down 36.80%.

- The new Zone 2 Sub Station is located at 9119 Merrill Road, 32225 is officially open.
- The old substation at Regency Square Mall will be used by Zone 6 (North District) JSO officers while their new substation is under constructed.
- Everyone was encouraged to participate in the 9 pm Routine; remember to remove valuables and firearms from your unattended vehicles. Remember to lock your car doors when you are not in the vehicle.
- The holiday season is upon us. Please make sure to place your valuables and new purchases in your trunk while out shopping and be aware of your surroundings.

There was a request for statistics on the number of arrests/closed cases there are in the GAB area.

There was a question asking regarding staffing and officers retiring, does JSO have good staff levels? It was confirmed that their staff numbers are good, have students enrolled in the academy and will have a graduating class going out on their own in January 2022.

There was request for an update on the fire at Mascara's Gentlemen's Club, located at 3225 Southside Boulevard. Lt. Terrell confirmed that JDRF responded to a fire call and put out the fire at this location this morning. Once the fire was extinguished a deceased body was found in a storage room. There is an investigation underway in regarding both the fire and the loss of life.

JFRD – Battalion Chief Clemons, Rescue Division provided the following updates:

- JFRD request for service calls (citywide) for October 2021 consisted of 27,422 EMS calls and 5964 fire calls.
- The official ground breaking for the new fire station (Station 65) off Arlington Road(near Atlantic Boulevard) will take place in January 2022.
- No updates or additional information was provided regarding the fire at Mascara's Gentleman's Club last night.

JTA – Cheryl Riddick shared:

- JTA has many employment opportunities available in many different departments of JTA. Earlier in the day, Ms. Riddick had Rosemary email a flyer to the CPAC that provided complete details on employment opportunities.
- There was an update requested for the JTA Mobility Works San Pablo Road project. According to the Mobility Works San Pablo Project Team, this construction project was scheduled to begin in late fall 2021, but the team is still working on securing a permit(s) that are outstanding. The new anticipated start date is Winter 2022. Permit challenges from the public held up the SJRWMD (St. Johns River Water Management District) permit. As of 2020 permits are issued separately by the ACOE (Army Corps of Engineers) and DEP (Department of Environmental Protection) as well. This used to be a joint permit. JTA has the SJRWMD and ACOE permits but are waiting to obtain the FDEP (Florida Department of Environmental Protection) permit.

Municipal Code Compliance – Ernest Murphy provided the following updates:

- In the past 30 days, 1088 inspections were conducted.
- A systematic inspection was completed in the North Beach area and 146 violations were cited.
- The next systematic inspection will be held in the Arlingwood community starting November 29, 2021.

- All outfall ditches will be cleaned in the upcoming year, this includes the Sandalwood Canal.
- The Right of Way and Storm water Maintenance team is out repairing broken or uneven sidewalks and cave-ins at this time.
- Chief Long was informed about the following concerns: illegal dumping at recycle center(s), concerns about illegal dumping into fallout ditches, location of several pot-holes, problem sidewalks, and missing portions of sidewalks, and street lights that are out on Kernan Boulevard North (from Landmark Middle School to Sabal Palms Elementary) on the east side of the road.

Ad Hoc Committees:

Nomination Subcommittee – Dedee Harper and Justine Wadyko attended the in-person meeting and conducted the election. North Florida Transportation Planning Organization (NFTPO) – Nicole Hamm informed the CPAC that Autumn Martinage, FDOT gave a brief presentation on FDOT tentative work program and the Strategic Intermodal System (SIS). In our area St. Johns Bluff Road and the Southside Connector will be resurfaced and widened in 2023; specifics on these projects will be shared once they become available. Ms. Hamm stated that she is aware there will be a project in the future (in 2023 or beyond) near a charter/elementary school off San Pablo Road, but she does not have the details. Once information is available on the San Pablo Road project, Ms. Hamm will share with the CPAC.

TRUE (Taxation, Revenue and Utilization of Expenditures) Commission – John Roberts shared three issues with the CPAC:

- The TRUE Commission has taken on a study to determine if JSO is staffed adequately for the size of our city.
- The TRUE Commission project that compared JSO to nine similar cities has been completed and the report is drafted. There is a little more work to be completed before they release it.
