Elected Officials Report:

Joyce Morgan, City Council District 1 shared the following information:

- Council Member Morgan will host her November Town Hall Meeting at Citadel Church, 1057 Arlington Road, 32211, at 6:00 pm on November 28, 2022.
- As an update to the LUZ Application (Ordinance# 2022-713) located at 8300 Merrill Road (formerly Lakeview Christian Fellowship Church). Council Member Morgan provided the following information:
 - Curtis Hart, LUZ Applicant Agent has spent a lot of time in the community to work with the adjacent neighbors in effort to resolve some/most of the issues associated with the project.
 - The Renew Arlington CRA Advisory Board has recommended denial on the project.
 - Council Member Morgan stated she requested a deferral on the application and is waiting on a traffic study.
- A Household Hazardous Mobile Waste collection event will take place at Ed Austin Regional Park on November 19, 2022, 9:00 am to 3:00 pm.

Staff Reports:

JSO- Assistant Chief Alicea – Crime stats for the past 30 days reflect property crime is down 17.8% and violent crime is down 8.55%. Year to date, violent crime is down 6.4% and property crime is up 7%. Most of the property crime can be attributed to auto burglaries, shoplifting and theft of catalytic converters.

A CPAC member informed Assistant Chief Alicea that there is a traffic situation on San Pablo Road as a result of how JSO is directing traffic by Alimacani Elementary School and the River City Science Academy Charter School; specific details related to the traffic issues were provided.

The CPAC members identified a couple of intersections where panhandling is creating traffic safety issues especially in areas with roadway construction.

JFRD - Lieutenant Jamar Smith reminded the CPAC that:

- We still have a couple weeks to go in hurricane season. Everyone was encouraged to download the JAXReady app to get up-to-date hurricane information.
- As the cooler weather arrives, JFRD recommends that homeowners have their chimneys inspected and/or cleaned prior to using them. Everyone was encouraged to operate space heaters safely and change the batteries in your smoke detectors.

Jacksonville Public Library (JPL) - Raelyn Wiirre provided the following updates:

- Starting on November 17, 2022, Friends of the Library will hold a book sale at the University Park Branch Library. The sale will conclude on Sunday, November 20, 2022.
- SHINE (Serving Health Insurance Needs of Elders) is a free program offered by the Florida
 Department of Elder Affairs and our local Area Agency on Aging. Specially trained volunteers can
 assist you with your Medicare, Medicaid, and health insurance questions by providing one-onone counseling and information. SHINE services are offered at various libraries throughout the

Parks, Recreation and Community Services – Daniel Piastuck provided the following updates:

- All of the parks, community centers and sports facilities will be inspected to see if any damage has occurred from Hurricane Nicole. So far, no significant damage was identified, but cleaning debris has been the biggest need.
- Playground installations are still expected and on schedule for Ed Austin Regional Park, Isle of Palms Park and Parkwood Heights Park for this year. In early 2023, playground equipment will be installed in Fort Caroline Park, Justina Road Park, Patton Park and Blue Cypress Park.

Municipal Code Compliance Division (MCCD) – Devron Cody shared the following updates:

- In Zone 2, there were 1048 inspections were completed in October and 471 inspections completed so far in the month of November.
- Last month a systematic inspection was completed in the East Arlington area and 203 violations identified.
- In late December 2022 or early January 2023, a systematic inspection will be conducted in the Woodland Acres area.
- A number of roofs have been tarped due to Hurricanes Ian and/or Nicole. An emergency
 declaration has been established to allow roofs to be tarped for up to six months without
 penalty.

• The Jacksonville Assistance and Relief or JAR program was discussed. The purpose of the Jacksonville Assistance and Relief Program is to facilitate a means of compliance to those who would otherwise be unable to achieve it due to disability or economic disadvantages. The program's objective is to provide the abatement services required at no cost to those citizens who qualify, thereby achieving compliance and beautification of the city while not unduly burdening its most vulnerable citizens.

Public Works – Steve Long provided the following project updates:

- Mr. Long confirmed that he is now the Director of Public Works Department.
- Director Long reminded the CPAC about the November 19, 2022, Household Hazardous Waste
 Mobile Collection event at Ed Austin Regional Park. Director Long also announced there will be
 a second Household Hazardous Waste Mobile Collection event on Saturday, December 17, 2022,
 at Blue Cypress Park. Both mobile collection events will be held 9:00 am to 3:00 pm.
- Citywide, there were only minor damages associated with Hurricane Nicole. The St. Johns River breached the bulkheads downtown and in parts of San Marco and Avondale. Several roads were flooded; the most severe flooding was in the Mayport area. The Jacksonville Beach Pier sustained minor damages as well. Citywide, 85 trees (on public property) fell; all the trees have been cleaned up and debris removed.

Subcommittee Reports (3-minute time limit):

Nomination Subcommittee: Amita Agnihorti, Kacy Evans, Dedee Harper, Lad Hawkins, and Justine Wadyko were the co-chairs/members of the Nomination Subcommittee. Ms. Wadyko presented the 2022 Slate of Officers to the CPAC members, Ms. Wadyko called three times for nominations from the floor and there were none. It was announced that Tim Keeley will serve as GAB CPAC Chair in 2023 and Delmas "Dedee" Harper will serve as Vice Chair.

LUZ (Land Use and Zoning)/Governmental Affairs – Vice Chair Tim Keeley - the LUZ subcommittee reviewed two LUZ applications that were on the monthly Planning and Development Report and took no

action on either application. The LUZ Subcommittee also discussed Ordinance # 2022-0713, the LUZ application that was discussed during Council Member Morgan's report. After a significant amount of additional discussion, the CPAC made a motion regarding the application. The motion is:

Denial of 2022-0713, 8300 Merrill Road. The Greater Arlington/Beaches Citizen Planning Advisory Committee has the following concerns regarding the application:

- Traffic Capacity: An ineffective measure, average daily traffic, was used rather than Peak AM
 and Peak PM for the traffic study. The additional traffic offers no mitigation for the existing
 traffic congestion during Peak AM and Peak PM.
- Traffic Safety: Connectivity to Hartsfield Road was abandoned in latest project plan. Hartsfield Road connectivity would aid with traffic ingress and egress and safety.
- Renew Arlington Community Redevelopment Agency (CRA) vision: Project scope is inconsistent with the Renew Arlington Community Redevelopment Agency (CRA) vision
 - This parcel was identified in the CRA as a catalytic node along the Merrill Road corridor leading to Jacksonville University.
- Stormwater: Compensatory storage requirement for stormwater in the CRA is unmet.
- Buffer Requisite: The siting of the multifamily buildings abutting the surrounding single-family residences creates a fire safety concern.
- Parking: The project's product mix with a significant concentration of 3-bedroom units offers inadequate parking, less than 1.75 per unit.
- The District 2 Greater Arlington/Beaches Citizen Planning Advisory Committee (CPAC) did not receive any notification about this application in its Land Use and Zoning subcommittee. Only concerned District 2 Greater Arlington/Beaches CPAC members and residents brought this application forward to the broader CPAC.

The motion passed unanimously.
