Call to Order/Verify Quorum: Chair Keeley called the October 2023 GAB CPAC meeting to order at 6:30 pm. Rosemary Wesolowski verified that a quorum was present.

Pledge of Allegiance

Approval of the Previous Meeting Summary – Approval of the September 2023 meeting summary was completed.

Presentation(s): Bird Friendly, Lights Out Northeast Florida Program, Elizabeth Filippelli and Peter Miller, informed the CPAC about the program.

There is a national initiative called Lights Out. The goal of the initiative is to encourage business owners, building managers and homeowners to turn off or reduce artificial lighting at night to ensure safe passage of birds during the spring and fall migration periods. Most birds migrate at night, and they use the moon and stars to navigate to their wintering grounds. The American Bird Conservancy estimates between 365 million and one billion birds are killed annually due to building collisions and/or confusion from sky glow.

Locally, the Lights Out Northeast Florida initiative was established and is a partnership between the Jacksonville Zoo and Gardens, Duval Audubon Society, and St. Johns County Audubon Society that united to bring awareness of this migratory challenge.

Ms. Filippelli and Mr. Miller shared various lighting techniques, discussed products and practices homeowners can implement/use to reduce collisions with glass and to reduce artificial lights. Elected Officials Report:

Joe Johnson, City Council District 1, Executive Council Assistant introduced himself to the CPAC and shared the following updates:

- Council Member Amaro and State Senator Clay Yarborough are working together regarding the current condition and future sale/use of Regency Square Mall. At this time the proposed buyer(s) has not been identified.
- The next Council District 1 Townhall meeting will be held at River City Baptist Church, 6801 Merrill Road, 32277 on October 23, 2023, at 6:00 pm.
- Two weeks ago, the Jacksonivlle City Council approved the 2023/2024 budget without a tax increase.
- Council Member Amaro is working with FDOT regarding the damaged trees on the Wonderwood Expressway. FDOT will replace the damaged trees.
- It was confirmed that the City Council voted to deny ordinances 2023-0433 and 2023-0434 for outdoor liquor sales and minimum distance for a liquor license at the Atlantis Events Center.
- Construction is underway at one of the former FBI buildings on the Arlington Expressway. It was confirmed that the other two FBI buildings will also be renovated and redeveloped as well.

Staff Reports:

JSO - Lieutenant Terrell announced:

- In the past 30 days, crime statistics were down overall in all zones.
- JSO and JFRD will host a Trunk or Treat on October 20, 2023, at 11901 Atlantic Boulevard in the parking lot. The event will be held from 6:00 to 8:00 pm.
- An overview of the ConnectDuval program was introduced to the CPAC. ConnectDuval is an
 opportunity for businesses and citizens to register their security cameras to assist JSO with
 solving crimes. Handouts were provided and Lieutenant Terrell answers questions about the
 program.
- Everyone was reminded to participate in the 9pm Routine. Please keep your vehicles locked when you are not in them and do not leave valuables and firearms in your vehicles.

JFRD – Lieutenant Jarmar Smith encouraged everyone to be mindful when using their fireplaces and space heaters. Keep space heaters at least three feet away from flammable materials (clothing, drapes, furniture) and make sure the wiring on the space heater is not damaged in any manner. Before lighting a fire, make sure your chimney is clean. Everyone was encouraged to place a fire screen in front of the fireplace fire box once a fire is lit. The CPAC members were reminded that fire extinguishers typically last five years. Everyone was encouraged to rotate the contents of their fire extinguisher.

- A copy of the University Park Branch Library activity schedule was provided to all the CPAC members.

Municipal Code Compliance Division (MCCD) – Robert Bautochka shared the following updates:

- In the past 30 days, 1242 inspections were completed, and 128 snipe/litter signs were removed.
- The first phase of a proactive inspection was completed on the Glynlea, Holiday Hills and Grove Park community. Due to the size of the Glynlea, Holiday Hills and Grove Park communities, the proactive inspections will be completed in three phases. The first phase generated 83 new cases.

- The second phase of the proactive corridor inspection in the Glynlea, Holiday Hills and Grove Park community will be conducted in October.
- The Jacksonville Assistance and Relief or JAR program was discussed. The purpose of the Jacksonville Assistance and Relief Program is to facilitate a means of compliance to those who would otherwise be unable to achieve it due to disability or economic disadvantages. The program's objective is to provide the abatement services required at no cost to those citizens who qualify, thereby achieving compliance and beautification of the city while not unduly burdening its most vulnerable citizens.

Public Works – Steve Long informed the CPAC that:

- Local fire hydrants are inspected, and a flow test is conducted annually.
- Do not dispose of your unwanted fire extinguisher in your garbage can. The proper way to dispose of a fire extinguisher is at a household hazardous waste event. It was recommended that you empty the container out as much as possible before disposal.
- We are still in hurricane season; don't let your guard down yet.
- Mayor Deegan has increased the Public Works mowing budget. All City of Jacksonville roadways
 will be mowed and edged 21 times per year. Each time the roadways are mowed, litter will also
 be collected.
- The Public Works Department is working on an updated website. The new website will allow the community to better understand what and where the various Public Works projects are ongoing.
