Call to Order/Verify Quorum:

Chair Parker Griffin called the SE CPAC meeting to order at 6:30 pm and welcomed everyone to the meeting at the Mandarin Senior Center and on Zoom. Rosemary Wesolowski verified that a quorum was present.

Approval of the Previous Meeting Summary – The March 2022 meeting summary was approved by the CPAC.

Presentation(s): Devron Cody, Code Compliance Supervisor, Municipal Code Compliance, presented on the services that Municipal Code Compliance Division (MCCD) offers to the community.

The Municipal Code Compliance Division is tasked with the enforcement of Chapter 518 – Property Safety and Maintenance Code, Chapter 656 – Zoning Code, Chapter 741 – Zero Tolerance for Litter Law, Chapter 745 – Addressing and Street Naming. These various chapters address housing safety, property maintenance, unsafe structures, nuisance properties, junk and abandoned vehicles and all zoning related violations.

Some of the most common violations that MCCD encounter are junk or abandoned vehicles; accumulation of garbage, rubbish, or debris; and excessive growth of weeds, grass, or noxious vegetation to name a few violations.

Municipal Code Compliance does not enforce: inoperable vehicles on public streets or right-of-way or the Jacksonville Traffic Code; subdivision deed covenants or restrictions; rental or lease agreements between owner and tenant; or blockage of city sidewalks by private vehicles parked in driveways.

Supervisor Cody reminded the CPAC that recreational vehicles should not be parked in the required front yard longer than 24 hours; do not erect any fence taller than 4 feet in height in a front yard in a residential district; do not park commercial vehicles in a residential neighborhood except for normal loading/unloading during normal time required for service at the dwellings and to apply for a business license, ensure you follow up to obtain a certificate of use permit from the Planning and Development Department.

If you are cited do not ignore the notification of violation. It is the property owner's responsibility to correct the violations, including rental or leased properties. If you need clarifications or if you are no longer the owner of the property, call 630-2489 immediately.

If the violation is not corrected by the property owner, the issue can be brought before a Special Magistrate to hear testimony from the Code Compliance Officer and the property owner to determine if the violation exists, set timelines for compliance, and possibly issue \$250 a day fine if the violation(s) is not corrected in the established timeline. Supervisor Cody provided a brief overview of the hearings and appeal process.

Lastly, Supervisor Cody reviewed Florida State Statue 125.69 (4)(b). This states that a code inspector may not initiate an investigation of a potential violation of a duly enacted code or ordinance by way of an anonymous complaint. A person who reports a potential violation of a code or ordinance must provide his or her name and address to the governing body of the respective board of county commissioners before an investigation occurs.

Elected Officials Report:

Danny Becton, City Council District 11 – addressed the following issues:

- America's Best Hotel on Dix Ellis Trail (off Baymeadows Road/I-95) has been a crime hotspot for
 the past couple of years. JSO, various City of Jacksonville staff members and Council Member
 Becton have tried various approaches to correct the array of problems at this hotel. The calls for
 service from JSO to this motel remain very high; May 2021 was the highest month with 818 calls
 for service. An injunction was filed in the court system regarding this property. Since the
 property is closing and structural repairs are needed, the future of this property is unclear.
- Regarding the street racing and blockage of intersections by car clubs, this is a work in progress
 and JSO is working to correct this problem and will provide Council Member Becton with
 updates over the next few days.

- Council Member Becton filed Resolution 2022-276, to encourage Mayor Curry to submit a proposed Fiscal Year 2022/2023 budget to the Jacksonville City Council using a Rolled-Back Millage Rate for Ad Valorem Tax Revenues for next year's budget.
- At Fort Family Regional Park, construction has started for a new baseball quadplex. The ball fields will be equipped with Astroturf. Additionally, new playground equipment and a new splash pad will be installed at Fort Family Regional Park.

Michael Boylan, City Council District 6 – provided the following updates:

Council Member Boylan held a City Council District 6 Townhall meeting at the Mandarin Senior Center on April 13, 2022. This townhall meeting was a bit different, Council Member Boylan conducted the meeting with a round-robin, small group discussion format. Representatives from the Public Works Department, JSO, Parks, Recreation and Community Services, FDOT, Solid Waste Division, Waste Pro and Council Member Boylan each chair a table for discussion as the attendees rotated from table to table which resulted in a lot of great information sharing and dialogue.

On April 14, 2022, Council Member Boylan held another community meeting at the Mandarin Senior Center to discuss the proposed Great Hearts Charter School after he received a lot of feedback from the community. Sixty community members attended and commented on the proposed school. This LUZ application was heard by the Planning Commission on April 21, 2022, and the Planning Commission did approve the application.

Council Member Boylan shared that he has received a lot of community input regarding illegal street racing and car clubs blocking roads and intersection. Everyone was encouraged to call JSO on their non-emergency line to report such activity; that phone number is 630-0500.

Staff Reports:

JSO (Jacksonville Sheriff's Office) – Sargent Wiggins – stated in the last 30 days overall crime in Zone 3 is down. Sargent Wiggins did confirm that JSO can assist communities with junk vehicles that are left in the right of way.

Sargent Wiggins addressed the recent outbreak of illegal street racing that is occurring all over the city. This is a problem that JSO is addressing both on a local and state level. If you hear or see any illegal street racing or car clubs gathering in a parking lot, please call 630-0500 to report. If you witness a dangerous situation involving racing, blockage of intersections or car clubs doing donuts in a parking lot, please call 911 to report.

Sargent Wiggins addressed concerns about dirt bike and/or All-Terrain Vehicles (ATV) riding in wooded areas behind subdivisions without permission of the landowner. Everyone was encouraged to call 630-0500 to report the activity and to also go to a JSO Substation to fill out a Trespass Authorization. It was reported that street racing on occurred Shad and Hood Roads.

JFRD - Captain Charles Johnson, Fire Prevention Bureau, provided the following updates:

- JFRD will replace or install new smoke detectors where needed and assist in replacing the
 batteries in existing functioning smoke detectors. Everyone was encouraged to test their smoke
 detectors by pushing the test button on the smoke detector. If your smoke detector is
 malfunctioning, please call 630-CITY (2489) to request to have a new smoke detector installed
 by JFRD.
- Everyone was encouraged to purchase and keep a small multi use fire extinguisher at their home. A fire extinguisher can last up to 10 to 12 years.
- It was encouraged that every household create a family evacuation plan and determine a rendezvous spot to reconnect in case of a fire or some other disaster.
- Captain Johnson shared information on a Knox Box Lock is. A Knox Box is a small, wall-mounted safe that holds keys for fire departments, emergency medical services, and police to retrieve in emergency situations. Local first responders hold master keys to all boxes in their response area, so that they can quickly enter a building without having to force entry or find individual keys held in deposit at the station.
- Hurricane season is upon us, and it is time to start preparing for the potential upcoming storms. Downloading the JAXReady app is a good first step.

JPL – Eric Soriano, South Regional Manager, provided the following updates:

JEA – Renee Goode provided the following details:

- JEA held their first Drive Electric event on April 16, 2022, at TIAA Bank Field. This event was to bring awareness to electric vehicles (EV). Local car dealers brought their electric vehicles to the event for rides and test drives. This event was a huge success.
- JEA has received a 2021 Safety Award from the Florida Municipal Electric Association (FMEA).
 This award is to recognize the utility companies' commitment to employee safety and safe utility operations.
- JEA has also received the Diamond Award; this is the highest level awarded by the American Public Power Association's (APPA) Reliable Public Power Provider program which recognizes utilities that demonstrate high proficiency in reliability, safety, workforce development, and system improvement.
- JEA held a groundbreaking ceremony on March 31, 2022, for the \$150 million Greenland Water Reclamation Facility which is already under construction on 80 acres near the eTown community. The Greenland facility is JEA's first water reclamation facility built since 1977. The Greenland facility will initially process 4 million gallons of wastewater per day, serving 22,800 JEA sewer customers and providing 5,700 customers with water for irrigation. The plant is scheduled to be operational in November 2024.

Municipal Code Compliance Division –In the past 30 days, 742 inspections were completed and year to date 7354 inspections were completed. Later this week a systematic inspection will be completed in the San Marco Community.

The Jacksonville Assistance and Relief or JAR program was reviewed. The purpose of the Jacksonville Assistance and Relief Program is to facilitate a means of compliance to those who would otherwise be unable to achieve it due to disability or economic disadvantages. The program's objective is to provide the abatement services required at no cost to those citizens who qualify, thereby achieving compliance and beautification of the city while not unduly burdening its most vulnerable citizens.

Public Works – Robin Smith informed the CPAC that:

- Construction has been completed on the new Senior Citizen Center located on Beach Boulevard (just east of Southside Boulevard) and it has been turned over to the Parks, Recreation and Social Services Department. The building should open for use soon.
- Pedestrian crosswalks will be installed along Gate Parkway; this project is underway and is approximately 25% complete.

- On Grant Road, near Pine Forest Elementary School there is a former health clinic building that will be converted into a Community Center.
- A dredging project will be conducted on Goodby's Creek. The dredge will begin at the John Lowe Boat Ramp and end at the St. Johns River. The dredge will begin this summer and is expected to be completed by the end of the year.
- Additional sidewalks will be added along Loretto Road.
- An intersection realignment will occur at Orange Picker Road and Brady Road; traffic should flow better after the project is completed.

Chief Smith heard comments regarding drainage problems in the South Woods community and took the location information from the meeting attendee. There was also a question regarding lighting along I-295, some of the lights are out. This outage should be reported to FDOT.

Subcommittee/Liaison Reports (3-minute time limit):

LUZ— On behalf of Craig Shoup, Chair Parker Griffin conducted the LUZ Subcommittee. The subcommittee reviewed eight LUZ applications and no motions or actions were recommended.

Membership – **Ramon Day** informed the CPAC that the Membership Subcommittee meeting was cancelled this month.

North Florida TPO - Jim Hill - not in attendance.

Park Safety Council – Walter Bryant informed the CPAC that the Park Safety Committee did not have a meeting this month. Mr. Bryant did share the following updates:

- Walter Jones Park is now a Monarch Waystation. A monarch waystation is a place that provide resources necessary for monarchs to produce successive generations and to sustain them on their migration between North America and Mexico.
- The annual Mandarin Garden Club Plant Sale will be held on Friday, April 29, 2022, and Saturday, April 30, 2022, 9 am to 2 pm at 2892 Loretto Road.

TRUE (Taxation, Revenue, and Utilization of Expenditures) Commission – Ramon Day provided the following updates:

- At the April TRUE Commission meeting, the commission reviewed the recent City Council Auditors report and a portion of this report focused on electronic fund transfers. It was identified that there was a disconnect between the Treasury Division and the Accounting Division on how and where to receipt funds. From this finding, the TRUE Commission recommended that the Accounting Division and the Treasury Division should coordinate their functions to properly record fund transfers, complete the transfers in a timely manner and to deactivate financial system access to all former employees.
- Ramon Day will be presenting a final report to the TRUE Commissioners regarding the JSO staffing, the need of mental health co-responders and the Kids Hope Alliance (after school programs). Mr. Day will ask to close the gap in staffing JSO, ask for proper funding for the Mental Health Co-responder Program and will hold off on recommendations for the Kids Hope Alliance.

Neighborhood Coordinator Report – Rosemary Wesolowski reminded the CPAC about the City of Jacksonville Neighborhood Department annual awards competition for 2022. The 2022 Neighborhood Awards Program is designed to recognize the efforts of organized neighborhood and civic groups in Duval County. Groups will be awarded for activities that emphasize volunteerism, leadership and collaborations that benefit their community with programs, events, artwork, or that physically and/or socially improve or beautify Jacksonville neighborhoods. Projects or activities which began and were completed between January and December 2021, are eligible, and applications must be received by June 3rd. Finalists will be notified a few weeks before the October 20th awards ceremony.

The City of Jacksonville is launching a contactless payment option for on-street parking in Downtown Jacksonville via ParkMobile. The ParkMobile system went live today and will be available on metered parking spaces where ParkMobile decals have been deployed. Additional information will be emailed to everyone tomorrow.

Chairs Report – Chair Parker Griffin welcomed and introduced new CPAC member Linda Gail Rowe representing the Lake Mandarin HOA.

Chair Parker Griffin informed the CPAC that she received a letter from the Finance and Administration Department, Budget Office. This letter was sent to each of the CPAC Chairs and it is an invitation to identify one priority capital improvement project for each neighborhood within our CPAC boundaries.

The projects must meet certain criteria, such as: the project must have a total cost greater than \$100,000 and have a lifespan of more than 10 years; must add to, enhance the value of, or extend the life of the City's physical assets. City's capital assets include land, buildings, parks, streets, utilities, and other items of value from which the community derives benefit.

Some examples include: improvements to an existing park, the purchase of land for a future park, road improvements, sidewalk and bike lane construction, intersection improvements and library enhancements.

Capital improvement projects do not include: routine maintenance (ditch cleaning, mowing, sidewalk repairs, pothole patching, repairing park amenities and other similar maintenance matters.

The SE CPAC will compile our list at the next meeting so we can meet our June 10th deadline.
