Call to Order/Verify Quorum:

Chair D'Onofrio called the October 2019 SE CPAC meeting to order at 6:30 pm. Rosemary Wesolowski verified that a guorum was present.

Approval of the Previous Meeting Summary:

The September 2019 meeting summary was approved by the CPAC.

Presentation(s):

The Honorable Scott Wilson, City Council President, Council District 4 introduced himself and provided the CPAC his personal and professional history. As City Council President, one of his first tasks was to work on the 2019/2020 City of Jacksonville Budget. Some of the items included in the budget are \$400 million for JSO and \$240 million for JFRD. Council President Wilson shared two new capital improvement projects in the SE district.

A new 6000 square foot Senior Citizen Center will be constructed on Beach Boulevard, just east of Southside Boulevard. The design for the center has been completed; construction should begin in 2020. A master plan has been created for the new Ivey Road Park; this park is located at 9000 Ivey Road, 32216. Phase I amenities of the Ivey Road Park will include multi-use fields, walking trails, a dog park, skate spot and a large assortment of play equipment. The park will be built on a former sand dune off Southside Boulevard near Southside Estates Elementary School.

City Council President Wilson informed the CPAC that he served as a mentor to high school students at Take Stock in Children for 9 years. He currently serves as a mentor at the Florida

Youth Challenge Academy as well as serving as the Vice-President of Walk-Off Charities, which provides instructional free baseball clinics to elementary school students in the form of student field trips. The years of mentoring has brought about his involvement with the Boots and Badges Mentoring Program. This program will pair Jacksonville's youth with members of the FOP and IAFF in effort to make a positive impact on the children's lives. At this time Boots and Badges has 30 to 35 volunteers that focus on children in low income communities. Currently, the mentees are emphasizing education and organized sports. Through the Boots and Badges program, Council President Wilson plans to grow youth sports activities/opportunities throughout Jacksonville.

Elected Officials Report:

Michael Boylan, City Council District 6– informed the CPAC that as he started researching information in regard to the sale of JEA, it became apparent he needed additional information to make an informed decision. In effort to have a better understanding of the process and potential outcomes, a series of workshops called JEA Fact Finding Workshops have been created.

Council Member Boylan provided a schedule of the JEA Fact Finding Workshops to all in attendance. The first workshop will be held on November 6, 2019, at 11:00 am in City Hall, 117 W. Duval Street, 32202, in the Lynwood Roberts Room on the first floor. The topic of the first workshop will define the role of the independent authorities in Jacksonville. The public has the opportunity to attend, learn and listen in person or online. The meetings are scheduled to last approximately 90 minutes and the dates were scheduled to be held the day before a City Council meeting. Due to time limitations at the meeting there is not time for public comment, but Council Member Boylan encouraged all to attend City Council meeting the next night to share, comment or communicate with City Council on this subject.

Council Member Boylan confirmed that City Council is the final authority if the sale of JEA will proceed and/or if the sale will make it to a ballot. Lori Hershey, Duval County School Board President stated Duval County Public Schools used the same engineering firm that the City of Jacksonville uses to complete an in-depth Facilities Index Report which included all 165 schools. Based on the age and condition of the schools, this information from the report was used to determine the priority order of repairs. The report also addresses schools that are under-utilized. Due to under-utilized schools, 47 local schools will be consolidated into 25 schools.

School safety and security is taken very seriously. Today there was a bomb threat at Mandarin High School. Superintendent Green and the Duval County School Board plan to hold a community meeting for those that attend Mandarin High School; no details about the upcoming community meeting have been determined yet.

Good news, Mandarin Oaks Elementary is the only school in Northeast Florida to have Project Lead the Way distinction. Project Lead the Way is a STEM hands on program offered at this K-5 school. Project Lead the Way was expanded in DuPont Middle and Mandarin Middle Schools. Students that follow that Project Lead the Way track can continue all the way to Atlantic Coast High School.in this learning path.

Atlantic Coast High School has started an Engineering Program and partnered with JEA. Mr. Wright from DCPS who was also in attendance was available for any additional questions about the engineering program. Mr. Wright is working very hard to strengthen the technical career education offered at DCPS.

Staff Reports:

JSO (Jacksonville Sheriff's Office) – Lieutenant Dash announced overall crime in Zone 3 is down except robbery to individuals and robbery to businesses. As the holidays get closer, these types of crimes tend to increase most often due to shop lifting. Another crime JSO would like us to be aware of is credit card skimmers. Credit card skimming involves thieves attaching devices on gas pumps, ATMs and other machines that read and gather your card information. The skimmers read the magnetic strip on the card, which gives fraudsters the full name on the card, the credit card number and the expiration date. Thieves can either sell your information on the dark web or use it to steal your identity, charge up your credit card or even get access to the money in your bank account. Skimmers are designed to fit snugly over the scanner, making it nearly impossible to tell something is not right. If you have the time to walk in to the station to pay for your gas with cash, it is recommended.

Lieutenant Dash stressed the 9:00 pm Routine; everyone was encouraged to not leave money, valuables, car keys, wallets/purses and guns in their vehicles unattended.

Chair D'Onofrio informed the CPAC that Lieutenant Dash and two other officers were recognized for their bravery after responding to a 911 call that someone had driven a car into St. Johns River near the Museum of Science and History in August 2019. The CPAC expressed their respect and support with a round of applause.

LUZ (Land Use and Zoning)/Governmental Affairs – On behalf of LUZ Subcommittee Chair Pete Gentry, Arimus Wells informed the CPAC the LUZ Subcommittee reviewed 9 LUZ applications tonight, but no motions or actions were made.

North Florida TPO – Jim Hill educated the CPAC about the draft 2045 Coast Feasible Plan and shared the proposed projects in the Southeast District that are on the draft plan. This is a long term draft proposal. Mr. Hill will keep us updated on the status of the draft. Proposed projects in the Southeast District are:

Southside Boulevard at Deerwood Park Boulevard – modify the intersection - \$9,525,000 – 2019-2025 timeline

Southside Boulevard at Gate Parkway – modify the intersection - \$93,322,000 – 2019-2025 timeline Beach Boulevard at Southside Boulevard – modify the intersection - \$5,606,000 – 2019-2025 timeline

J. Turner Butler Boulevard at San Pablo – modify the intersection - \$13,125,000 – 2019-2025 timeline

Baymeadows Road at I-95 - turn lane improvement - \$1,805,000 - 2019-2025 timeline

Southside Boulevard from J. Turner Butler to Beach Boulevard – widen to six lanes - \$19,656,000 – 2031 – 2035 timeline

Southside Boulevard at Baymeadows Road – modify interchange - \$7,500,000 – 2031-2035 timeline

Southside Boulevard at J. Turner Butler Boulevard – modify interchange - \$29,400,000 – 2036-2045 timeline

Philips Highway at I-95 Avenues Mall to J. Turner Butler Boulevard – widen to six lanes and add trail - \$47,551,000 – 2031-2035 timeline

Philips Highway at SR 9B to I-295 – widen to six lanes and add a trail - \$15,007,000 – 2036-2045 timeline
