Call to Order/Verify Quorum:

Chair D'Onofrio called the November 2020 SE CPAC meeting to order at 6:33 pm and welcomed everyone to the first in-person SE CPAC meeting at the Mandarin Senior Center. Rosemary Wesolowski verified that a quorum was present.

Elected Officials Report:

Michael Boylan, City Council District 6 – informed that he has two upcoming meetings: tomorrow there will be a meeting to discuss Lot J and later this week there will be a meeting to work on the re-write of Article 21 in the Charter of the City of Jacksonville.

Article 21 pertains to JEA and will address items such as compensation of officers; awards of contracts; transparency, reporting and accountability. This is a lengthy process; Council Member is optimistic that the work will be completed soon.

It was recognized that many of the roadway medians in the Mandarin area are in dire need of maintenance. Council Member Boylan discovered there are several different contractors that maintain the medians and will work to get the proper maintenance completed. Staff Reports:

JSO (**Jacksonville Sheriff's Office**) – Sargent T. Viner represented JSO and informed the group that in Zone 3 in the last 30 days that has been a slight uptick in robberies, home invasions and auto thefts. During the same time span there has been a decrease in both business and auto burglaries.

Sargent Viner encouraged everyone to be mindful when having packages delivered to their home. Since the onset of the pandemic and with the upcoming holidays many are having packages delivered to their home. Often these packages are left unattended for hours, thus providing more opportunities for "Porch Pirates" to steal their deliveries. To combat this type of theft, it was recommended to have packages delivered to your work; to a neighbor's house or to a family members home that is at home during the day.

The CPAC was reminded about the 9 pm Routine; everyone was encouraged to not leave money, valuables, car keys, wallets/purses and guns in their vehicles unattended.

A CPAC member shared with Sargent Viner that there is a drag racing problem on San Clerc Road most nights between 10:30 pm and 1:00 am. The concern was noted, and Sargent Viner stated JSO is actively working to stop the drag racing in the e-Town area.

- Blue Cypress Golf Course is under renovation and is expected to open in Spring 2021
- The pool at Blue Cypress Park will be rebuilt and Pickleball courts will be added
- At Mandarin Park the restroom project is finished, and the kayak launch project will begin soon
- A small playground will be developed behind the South Mandarin Library
- Six Pickleball courts will be added at Walter Anderson Memorial Park, 2738 Orange Pickers Road Jacksonville FL 32223 (formerly know as Flynn Park), completion date is TBD
- Covid-19 testing will continue at the Mandarin Senior Center and there is hope to return to senior activities at the senior centers soon.

- There is a bid out for quad-baseball fields and a parking lot at the Fort Family Regional Park
- Deerwood Rotary Park will get a splash pad in the future
