Call to Order/Verify Quorum:

Chair D'Onofrio called the SE CPAC meeting to order at 6:30 pm and welcomed everyone to the meeting at the Mandarin Senior Center and on Zoom. Rosemary Wesolowski verified that a quorum was present.

Approval of the Previous Meeting Summary – The September 2021 meeting summary was approved by the CPAC.

Presentation(s): Council Member Becton informed the CPAC on City Council Redistricting.

Every ten years, with the release of the new census data, City Council must adjust the City Council district boundary lines to account for population changes that have occurred since the previous census data in 2010. The overall goal of redistricting is to rebalance the population within each of the 14 City Council districts, so each district has roughly the same number of residents. The districts that have

grown the most in population will experience the most geographic boundary changes. Overall, Duval County has grown by approximately 12 to 13 percent the past decade.

To accomplish the task of redistricting, City Council has created a special committee. The Redistricting Committee members include: Council Member Aaron Bowman – Chair; Council Member Danny Becton - Vice Chair; Council Member Garrett Dennis; Council Member Brenda Priestly Jackson; Council Member Randy White. In addition to City Council members, Duval County School Board Members Kelly Coker and Darryl Willie also serve on this special committee.

There are some specific requirements and timelines that are established by Federal, State, and local laws and must be followed during the redistricting process; they include:

- Selection of Redistricting Consultant The Redistricting Committee shall investigate possible persons or entities, including the Planning and Development Department (PDD), qualified to serve as a Redistricting Consultant. The Planning and Development Department was selected and will serve as the Redistricting Consultant in 2021/2022. The consultant (the Planning and Development Department) and the Redistricting Special Committee received the City's directives and were ready to work on various plan proposals when the final Census was certified on March 31, 2021.
- Obtain Legally Permissible Considerations for Redistricting in accordance with state, federal and case law The Redistricting Committee will hear from the Office of General Counsel about the criteria and analysis consistent with the current status of federal law and court precedents that will determine what rules must be followed in developing legally defensible districts and the Redistricting Committee will develop guidelines based off of these legal considerations.
- Schedule for Preparation of Plan to be Submitted to Council The Redistricting Committee shall adopt a schedule for preparation of a plan and present the plan to Council. This plan must be submitted by the Redistricting Committee to Council within 30 days after the U.S. Census data is certified, which was March 31, 2021. The redistricting consultant (the Planning and Development Department) began drawing alternative proposal maps in early 2021 using guidelines for new districts supplied by the Redistricting Committee and census data.
- Reapportionment Committees Present a Plan to the Rules Committee and City Council Within 150 days after the U.S. Bureau of the Census certification of the final population count for the City, the Redistricting Committee is required to submit a final proposed plan to Council, in the form of an ordinance that will be referred to the Rules Committee.

The Redistricting meetings are noticed and can be attended by the public. The meetings can be accessed virtually through the Zoom or you can attend in-person in City Council Chambers. City Council Chamber are located on the first floor in City Hall, 117 Duval Street N., 32202. Elected Officials Report:

Danny Becton, City Council District 11 – Extended an invitation to the CPAC to attend the Ribbon Cutting Ceremony for Fire Station 63 at 6530 Gate Parkway, 32256 on October 26, 2021, at 10:00 am. Fire station 63 will serve over 5,000 homes, 400 businesses, 30 apartment complexes, and many schools in the Gate Parkway area. These communities and businesses will now have faster response times and lower insurance rates as Jacksonville Fire Rescue Department Fire Station 63 is ready to serve the community.

Michael Boylan, City Council District 6 – provided the following updates to the CPAC members:

- The Four Seasons Hotel—Council Member Boylan wanted to share details of this proposed development in effort to have a better understanding of the finances behind the project and its benefits. Council Member Boylan views the proposed development as a unique opportunity to develop a key parcel of downtown which will create hundreds of jobs while providing a dollar-for-dollar return on investment (ROI) to the City of Jacksonville. Spending \$114 million in taxpayer funds can best be explained by reviewing the specifics:
 - The City's only cash outlay is \$26 million completion grant which is not available to the developer until after their (guaranteed) private investment of \$301 million is made.
 - Once operational, the developer will get a tax rebate totaling no more than \$47.7 million over a span of 20 years. Currently, the land is owned by the City of Jacksonville and generates zero revenue in the form of ad valorem taxes and hasn't for decades. Once developed, the developer will still be paying \$50.1 million in ad valorem taxes over the course of the same 20 years. The taxes broken down will provide \$15.9 million to the City of Jacksonville, \$1.4 million to the Water Management District and \$32.8 million to the Duval County School System.
 - The City of Jacksonville financial investments of \$26 million of CIP money will be used for improvements to the marina including a marina service building and the relocation of the fire station's dock, and the fire museum at the current Metropolitan Park.
 - The balance, \$20.6 million are noncash contributions the city will make in land conveyance, land swap and easement rights.
 - Because the developer has an active interest in the development and upkeep of adjacent parcels and the marina, they committed to contribute \$200,000 a year for 20 years (a total of \$4 million) for the maintenance of and programming for Metropolitan Park.
- American Rescue Plan (ARP) Funding American Rescue Plan Act of 2021 is part of the most recent round of COVID-19 relief legislation. Each City Council Member has recommended an organization to COJ administration that has had an impact on their respective City Council districts and have been impacted by Covid-19. Once the recommendation are submitted, the administration will determine the qualifications for the various organizations for the grant and to determine if the loss they experienced warrants the funds. If approved, the awarded organizations will have to adhere to a grant agreement, including an audit of how the funds are

- expended. The administration is using an outside consultant familiar with the ARP funding parameters to do much of that work.
- Council Member Michael Boylan informed the CPAC that he submitted a resignation letter to
 Council President Sam Newby to release him from the Safer Together Committee last week. This
 was a committee that was first created at the request of then-Council President Tommy Hazouri.
 The goal of Jacksonville's Safer Together Committee was to foster dialogue between the
 community and the Jacksonville Sheriff office. There has been over 20 hours of dialogue at the
 monthly workshops. The last two workshops had a change in character, participants got out of
 control and compromised the effectiveness of the workshops. The committee has been closed.

JSO (Jacksonville Sheriff's Office) – Assistant Chief Craig Waldrup, introduced himself and informed the CPAC that he is the new Assistant Chief for Zone 3. Municipal Code Compliance Division – Chief Michael Chao, Bradley Clayton, and Patrick Higdon were in attendance at the Mandarin Senior Center and Thomas Register attended via Zoom. Mr. Higdon informed the CPAC that 946 cases were inspected in the past 30 day and a systematic inspection was completed in the Windy Hills community.

There was a question inquiring how the systematic inspection locations are selected. Chief Chao informed the CPAC that systematic inspections can be requested by the community. Code Compliance monitors their computer system and phone calls they receive to determine what areas have the most complaints and concerns. Areas with the most concerns/complaints are often selected for a systematic inspection.

The Jacksonville Assistance and Relief or JAR program was discussed. The purpose of the Jacksonville Assistance and Relief Program is to facilitate a means of compliance to those who would otherwise be unable to achieve it due to disability or economic disadvantages. The Program's objective is to provide the abatement services required at no cost to those citizens who qualify, thereby achieving compliance and beautification of the city while not unduly burdening its most vulnerable citizens.

Chief Chao reminded the CPAC about State Bill 60 (SB 60). SB 60 amends the county and municipal code enforcement statutes to prohibit county and municipal code inspectors and code enforcement officers from initiating an investigation into violations of city or county codes or ordinances based upon an anonymous complaint. It also requires that an individual making a complaint of a potential violation provide his or her name and address to the local government body before an investigation may occur.

The prohibition does not apply if the code inspector or code enforcement officer has reason to believe the alleged violation presents an imminent threat to public health, safety, or welfare or imminent destruction of habitat or sensitive resources. The Bill went into effect July 1, 2021.

Public Works – Robin Smith provided the following updates:

- Fire Station 63 on Gate Parkway will open soon and land has been obtained for Fire Station 74 in the e-Town community.
- A traffic calming project is underway on Gate Parkway (between Southside Boulevard and the St. Johns Town Center); the project will provide elevated sidewalks and crosswalks.
- The Southside Senior Citizen Center(on Beach Boulevard, just east of Southside Boulevard) is nearing completion and should be finished by the end of the year.
- There was a request for a new trash collection calendar. Mr. Smith requested an email sent to him with the home address and he would forward to correct division.
- There was a question addressing road repaving. Mr. Smith requested those interested to send him an email with an address and he would forward to the correct division.

Subcommittee/Liaison Reports (3-minute time limit):

LUZ – **Joanne Parker Griffin** and the LUZ Subcommittee reviewed seven LUZ applications. The LUZ Subcommittee would like to make an updated recommendation on an LUZ application that was review at the September 2021 CPAC meeting. The recommendation/motion to the CPAC is:

Deferral of Ordinance 2021-0650 PUD 2522/2630 Belfort Road, 0 Belfort Road and 0 Synhoff
Drive seeks to rezone 15.45 acres of land from RLD-60 to PUD to permit for 60 townhomes. The
CPAC voted to request denial 2021-0650 in light of new environmental issues, such as flooding
and the destruction of natural wild animals and bird habitats that will be a direct result of the
current site plans for 60/56 townhome units. This site plans does not conform to the physical
type of home, frontage, and layout of the surrounding area.

This project is also inconsistent with the current single family residential communities currently in this area. Reference is made to Zoning Code 656-125 — Limitations on rezoning of land, Item C-3 states uses permitted under the proposed rezoning will not be consistent or compatible with the existing and proposed land uses and zoning of adjacent and nearby properties or the general area or will deviate from an established or developing logical and orderly development pattern. Currently the 15.45+- acres is surrounded by numerous single-family home communities and is also an active area for wildlife including several species of turtles and birds. It is also currently the home of an active Bald Eagle nest.

The surrounding neighborhood community realizes that building will occur on this land but not to the magnitude of 60/56 townhomes on this site. The original planned permit identified 21 single family homes to be built. This is acceptable and is in concert with the surrounding areas.

The motion passed unanimously.

North Florida TPO – Jim Hill – no report

Park Safety Committee – Walter Bryant informed the CPAC that the Park Safety Committee held their second meeting this morning. It was a short meeting, but the Parks Safety Supervisor reported that there were no known safety issues at this time. A significant upgrade of all the playground equipment is underway. Several pieces of playground equipment deemed unsafe have been removed and others have been repaired. The next meeting will be held on November 22, 2021.

TRUE (Taxation, Revenue, and Utilization of Expenditures) Commission – Ramon Day reported Sheriff Williams attended the October 7, 2021, TRUE Commission meeting and answered all the questions that the TRUE Commission sent him last month. Some of the details that Sheriff Williams provided included:

- JSO has received a major upgrade in technology throughout the department.
- JSO has a total of 1827 sworn officers; 1400 of them have been hired in the past six years.
- JSO has a focus on improving community relations.
- Sheriff Williams stated that he requested funding for additional staff. Based on the population to officer ratio and several comparison related analyses JSO is understaffed.
- The Sheriff stated that State Law limits the power/involvement that a Citizens Review Board would have because we are a consolidated government.
- Due to the volume of calls for service and current staffing levels, JSO officers are only allotted one day of training per year and have limited opportunity for community services work.
- The TRUE Commission does feel that they have enough information to finalize their audit and report. Their report will include the request for an additional 380 sworn officers.

In addition to his TRUE Commission report, Mr. Day updated the CPAC on his work with re-establishing the Jacksonville Community Council Inc. (JCCI). The updates on the JCCI include:

- The JCCI has been meeting at least monthly since April 2021.
- They have reclaimed the JCCI.org domain
- The mission statement, vision statement and new by-laws have been adopted.
- The board membership has been expanded from 11 to 15 individuals.
- Once all the board members have all been selected, the board will be comprised of 8 women and 7 men. The racial breakdown will be 8 Caucasians, 4 African Americans, 2 Latinos, 1 Asian American and 1 Pacific Islander.
- JCCI members have conducted outreach to local agencies/stakeholders to determine their interest in the new JCCI.
- A membership drive will be forthcoming, and several City Council Members will seek funding to support the organization.

Neighborhood Coordinator Report – Rosemary Wesolowski – reminded the CPAC that the Nomination Subcommittee has formed. The Nomination Subcommittee members are Nancy Barry, Donna Herrin, Jim Hill, and Kathleen Perera. The Nomination Subcommittee hybrid meeting will be held on Wednesday, October 13, 2021, 6:30 pm at the Southeast Regional Library and on Zoom. If you would like to make a nomination, please contact Rosemary or one of the subcommittee members. The Matching Grant programs is open.
