I. CALL TO ORDER

Renew Arlington CRA Advisory Board Chairman Tuohy called the Renew Arlington CRA Advisory Board meeting to order at approximately 3:30 p.m.

Approval of the December 12, 2018 Meeting Minutes

E-18-100 Application

Mr. Connor Corrigan-Planning and Development, presented application E-18-100, an application for a take-out only restaurant located at 2944 Justina Road, Jacksonville, FL 32277. Councilwoman Morgan asked if the CPAC had taken a position on this application. Ms. Connie Patterson, Planning and Development Department, stated that the CPAC has taken no position. Renew Arlington Advisory Board Member Salem asked for the reason this application needed an exception. Mr. Bill Killingsworth responded the CRO does not allow for restaurants by right, but with an additional exception, one can be granted.

Renew Arlington Façade Grant Program Funding

Renew Arlington Advisory Board Chairman Tuohy presented the current FY 18/19 budget and the amended FY 18/19 budget to be presented to the Renew Arlington CRA Agency Board on February 12, 2019 at 2:00 p.m.

The amended FY 18/19 budget proposes to transfer \$225,000 from the Unallocated Plan Authorized Expenditures to the Façade Grant Program. Mr. Wendland further explained there is currently \$25,000 in the Façade Grant FY 18/19 budget. The amended FY 18/19 budget would provide a total of \$250,000.
