



## **Notice of Public Hearing for Proposed Land Use Change**

Large scale land use amendment application L-5513-21A was filed on March 3, 2021 as Ordinance 2021-133.

The subject site is approximately 204.90 acres and is located with an address of 16198 Butch Baine Drive with access to the property to the south off of Pecan Park Road.

The current land use categories are Agriculture-2 (AGR-2) and Agriculture-3 (AGR-3) in the Rural Development Area. The proposed land use categories are Low Density Residential (LDR) and Conservation (CSV) in the Suburban Development Area. 3. If the meeting has not already started and join before host is not enabled, you will be prompted to press # to wait if you are participant.
4. You will be prompted to enter your unique participant ID. This only applies if you have joined on the computer or mobile device or are a panelist in a webinar. **Press # to skip.**

If you join by computer or mobile device later, you can enter the Participant ID to bind your phone and device session together and show your video when you speak on the phone. To enter your participant ID once you are in the meeting, enter **#Participant ID#** on your phone.
