



Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application L-5535-21C was filed on April 21, 2021 as Ordinance 2021-226.

The subject site is approximately 5.5 acres and is located with an address of 0 Normandy Boulevard, on the north side of Normandy Boulevard Road between Guardian Drive and Lamplighter Lane.

The current land use category is Community General Commercial (CGC). The proposed land use category is Medium Density Residential (MDR). Plan category descriptions can be found on the Planning and Development Department website.

INSTRUCTIONS: JOINING A MEETING BY DIAL-IN PHONE ONLY

3. If the meeting has not already started and join before host is not enabled, you will be prompted to press # to wait if you are participant.
4. You will be prompted to enter your unique participant ID. This only applies if you have joined on the computer or mobile device or are a panelist in a webinar. **Press # to skip.**

If you join by computer or mobile device later, you can enter the Participant ID to bind your phone and device session together and show your video when you speak on the phone. To enter your participant ID once you are in the meeting, enter **#Participant ID#** on your phone.

PHONE CONTROLS FOR DIAL-IN PHONE ONLY PARTICIPANTS

 - Host will “**ONLY**” recognize or call on speakers using the **ELECTRONIC “RAISE HAND”** feature located within the Zoom App *9 ... wait to be recognized. (Must have a Microphone and Speakers on phone to participate with the function.)
