



## **Notice of Public Hearing for Proposed Land Use Change**

Large scale land use amendment application L-5778-22A was filed on February 22, 2023, as Ordinance 2023-116.

The subject site is approximately 127.95 acres and is located with an address of 0 Roosevelt Boulevard, 4811 and 4837 Collins Road, between Roosevelt Boulevard and Ortega Bluff Parkway.

The current land use category is Light Industrial (LI), Medium Density Residential (MDR), and Residential-Professional-Institutional (RPI). The proposed land use category is Residential-Professional-Institutional (RPI) and Medium Density Residential (MDR).
