



Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application L-5860-23C was filed on April 3, 2024, as Ordinance 2024-273.

The subject site is approximately 4.48 acres and is located with an address of 851 North Market Street, between Market Street North and Liberty Street North.

The current land use category is Recreational Open Space (ROS). The proposed land use category is Community General Commercial (CGC). Plan category descriptions can be found on the Planning and Development Department website.
