WILLIAM SHEPPARD, COLVIN'S ATTORNEY, SPOKE TO THE ADVISORY COMMITTEE REFERENCING A DISABILITY PENSION THAT WAS AWARDED TO A POLICE OFFICER IN 2013. THE SAME PHYSICIAN THAT EVALUATED THE POLICE OFFICER, EVALUATED COLVIN. SIMILIAR SITUATION. THREE MEMBERS OF THE ADVISORY COMMITTEE THAT APPROVED THE 2013 DISABILITY PENSION, ARE STILL ON THE COMMITTEE. CANNOT IGNORE PRESIDENCE SET WITH THAT CASE.

SEVERAL COMMITTEE MEMBERS INTERVIEWED MR. COLVIN. THE LAST 4 OR 5 YEARS HAVE BEEN DIFFICULT FOR HIM. HE IS WORRIED ABOUT HIS FAMILY AND WAS VISABLY UPSET. HIS ATTORNEY CONFIRMED THAT THIS HAS BEEN A LIFE CHANGING EVENT FOR STEPHEN.
